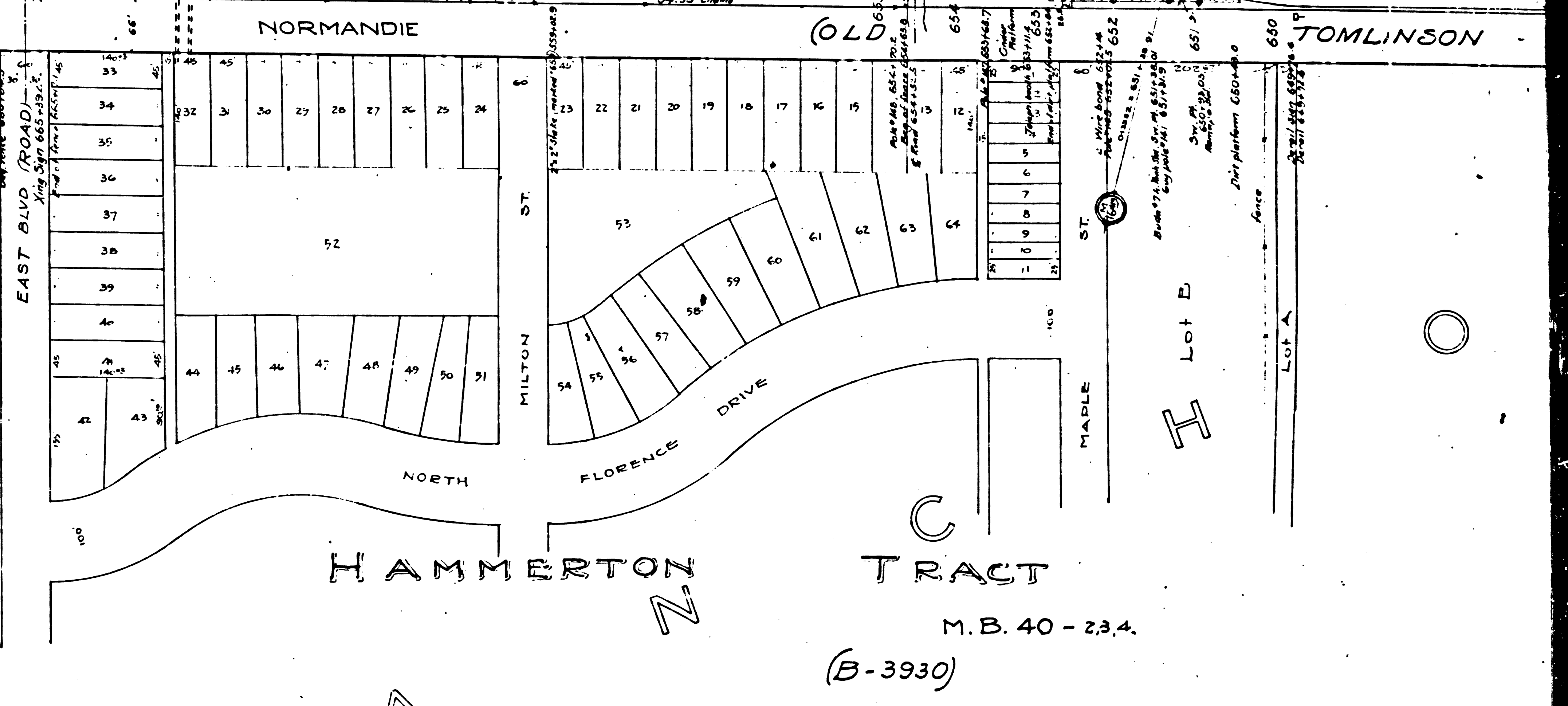


EAST BOUNDARY LINE, CITY OF LOS ANGELES

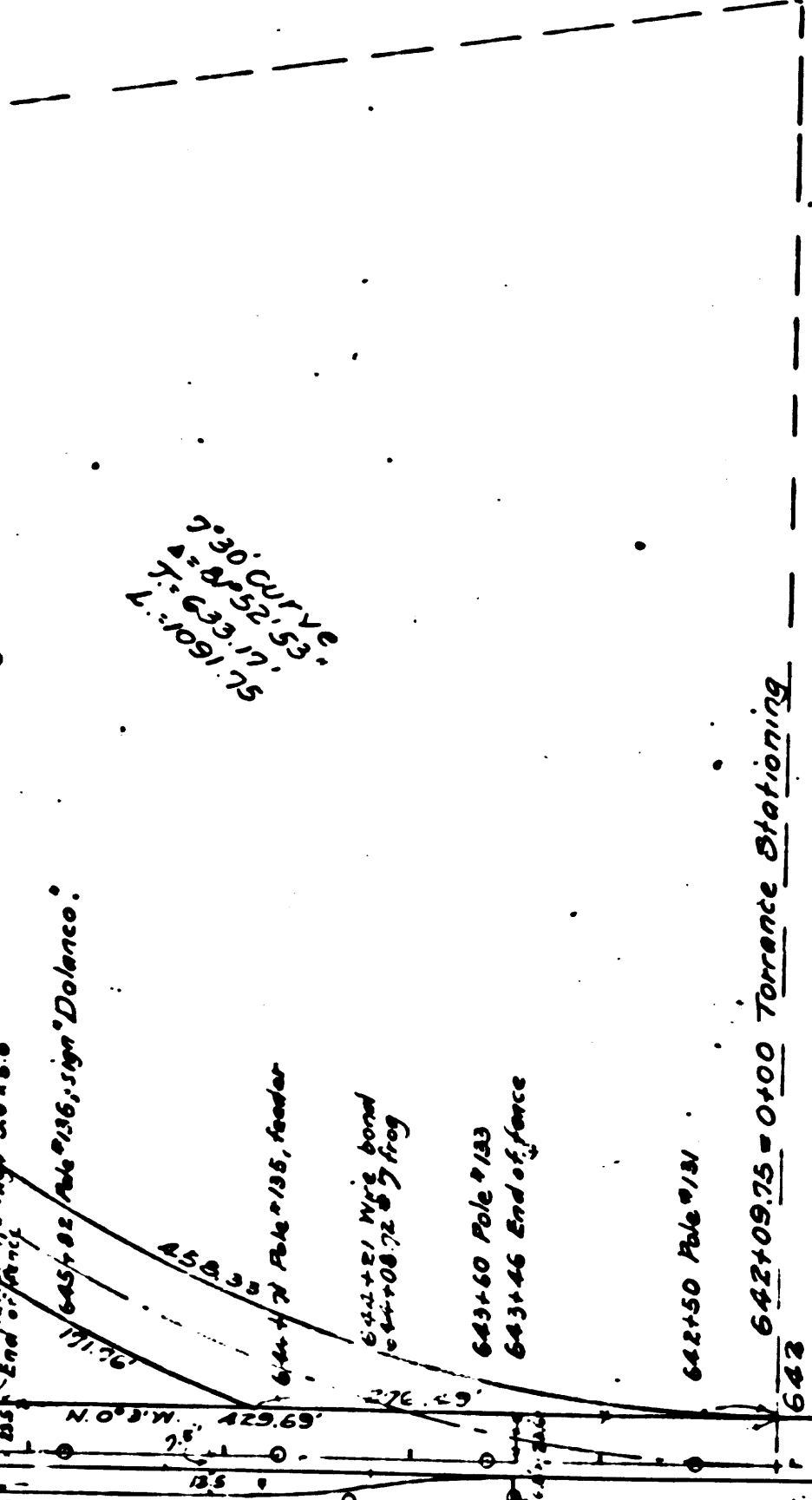

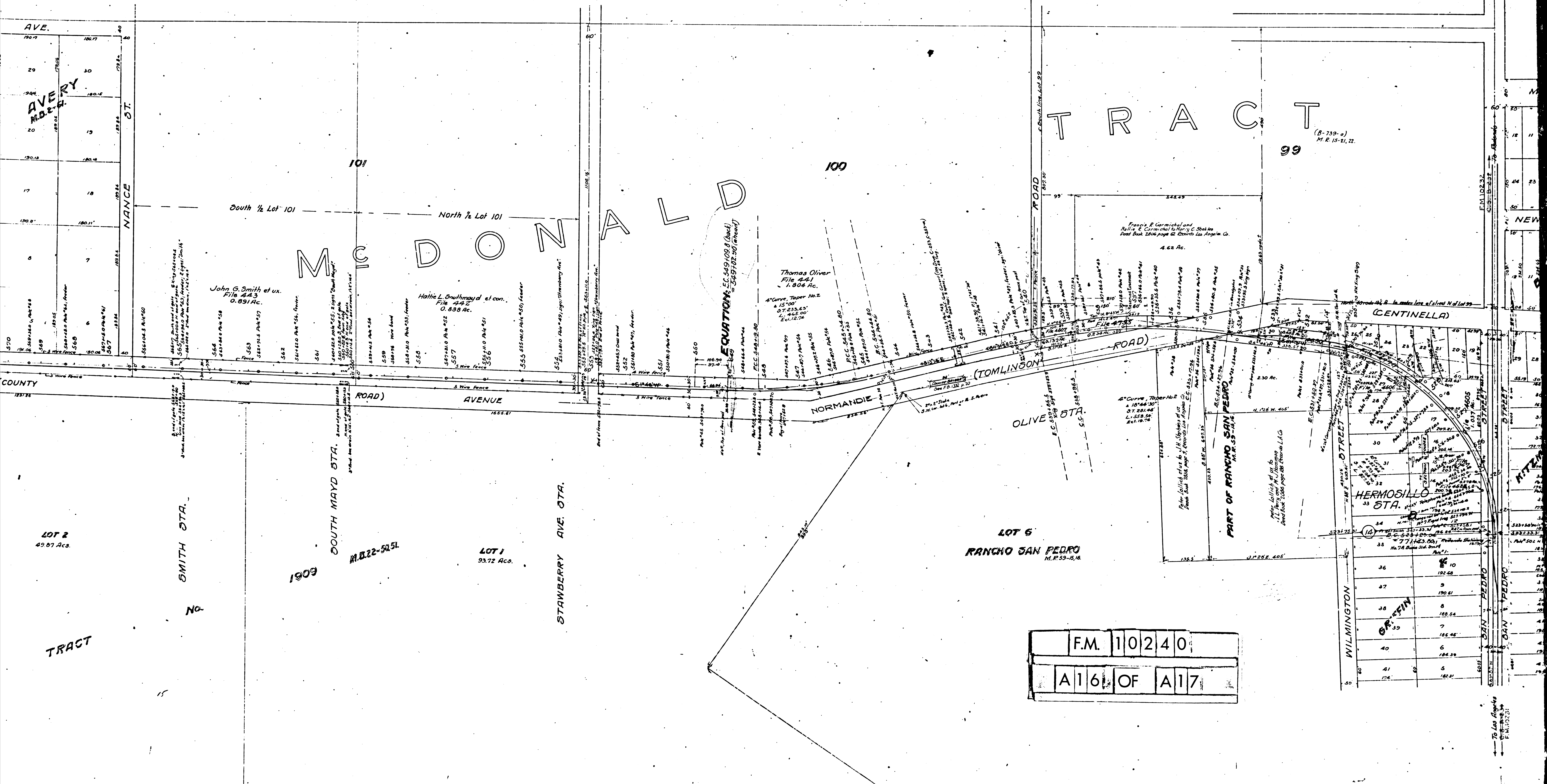

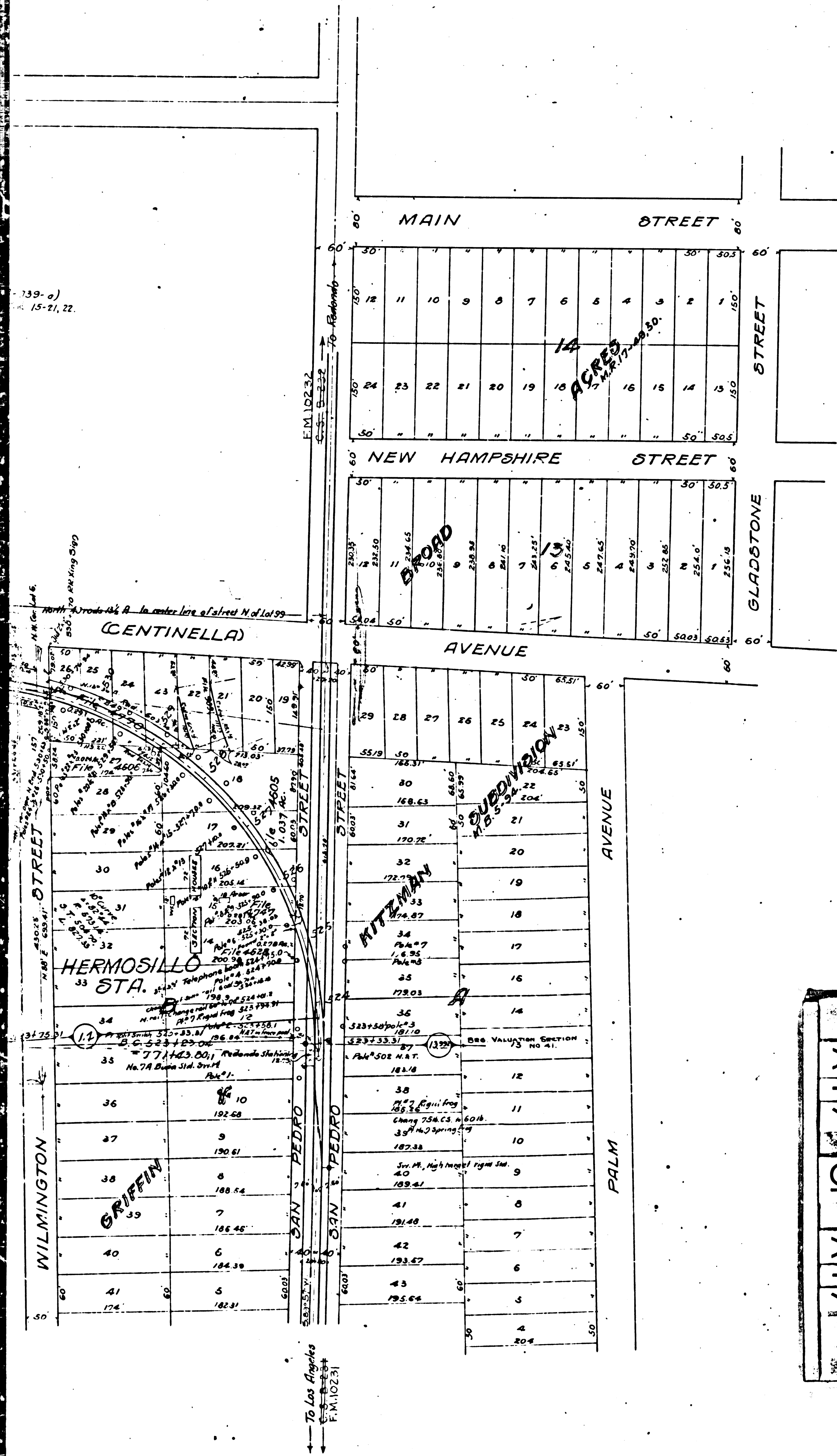
