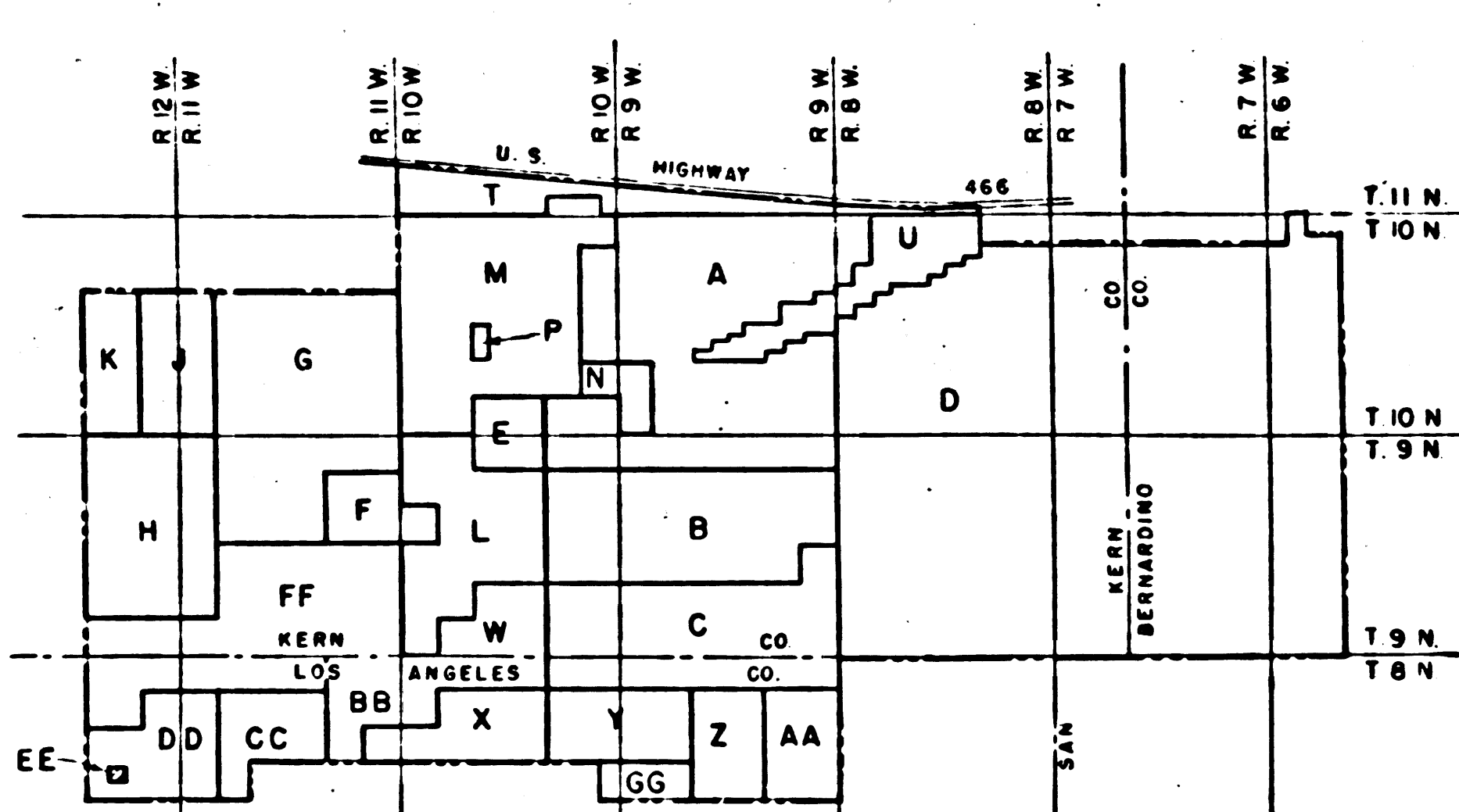

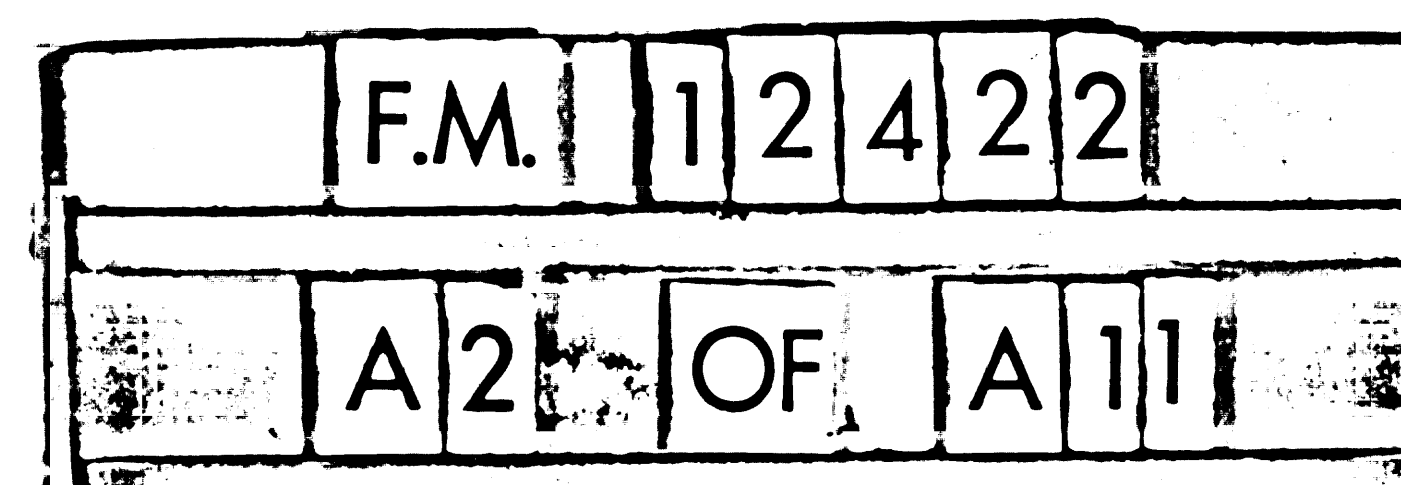
VICINITY MAP

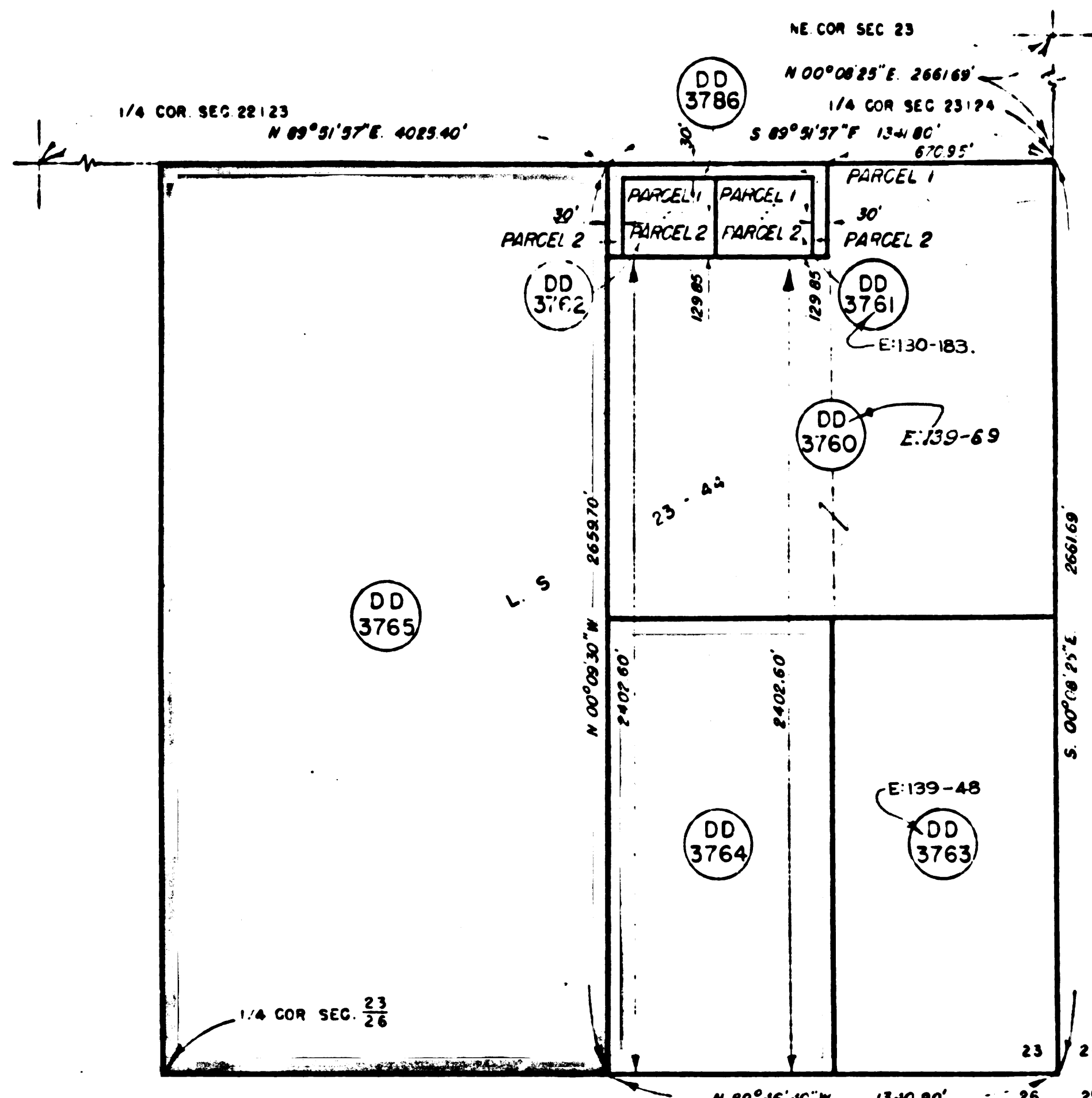

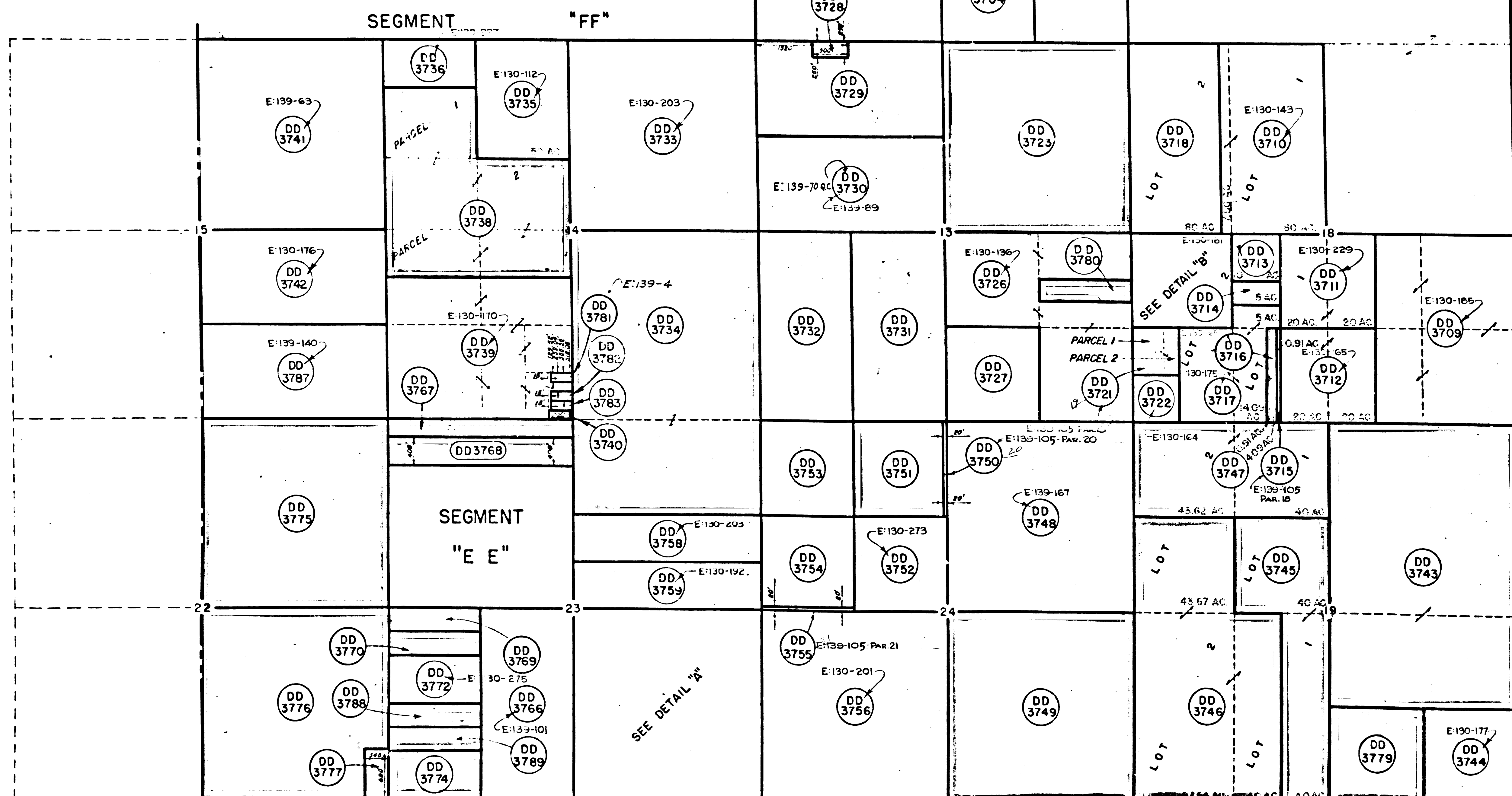
DETAIL "A"

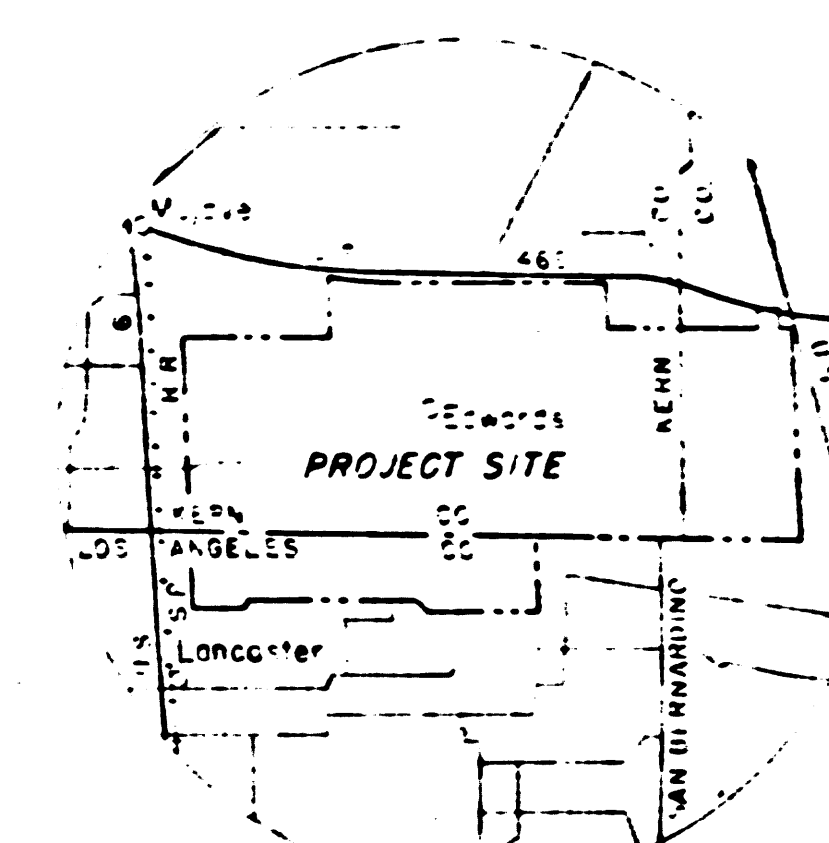

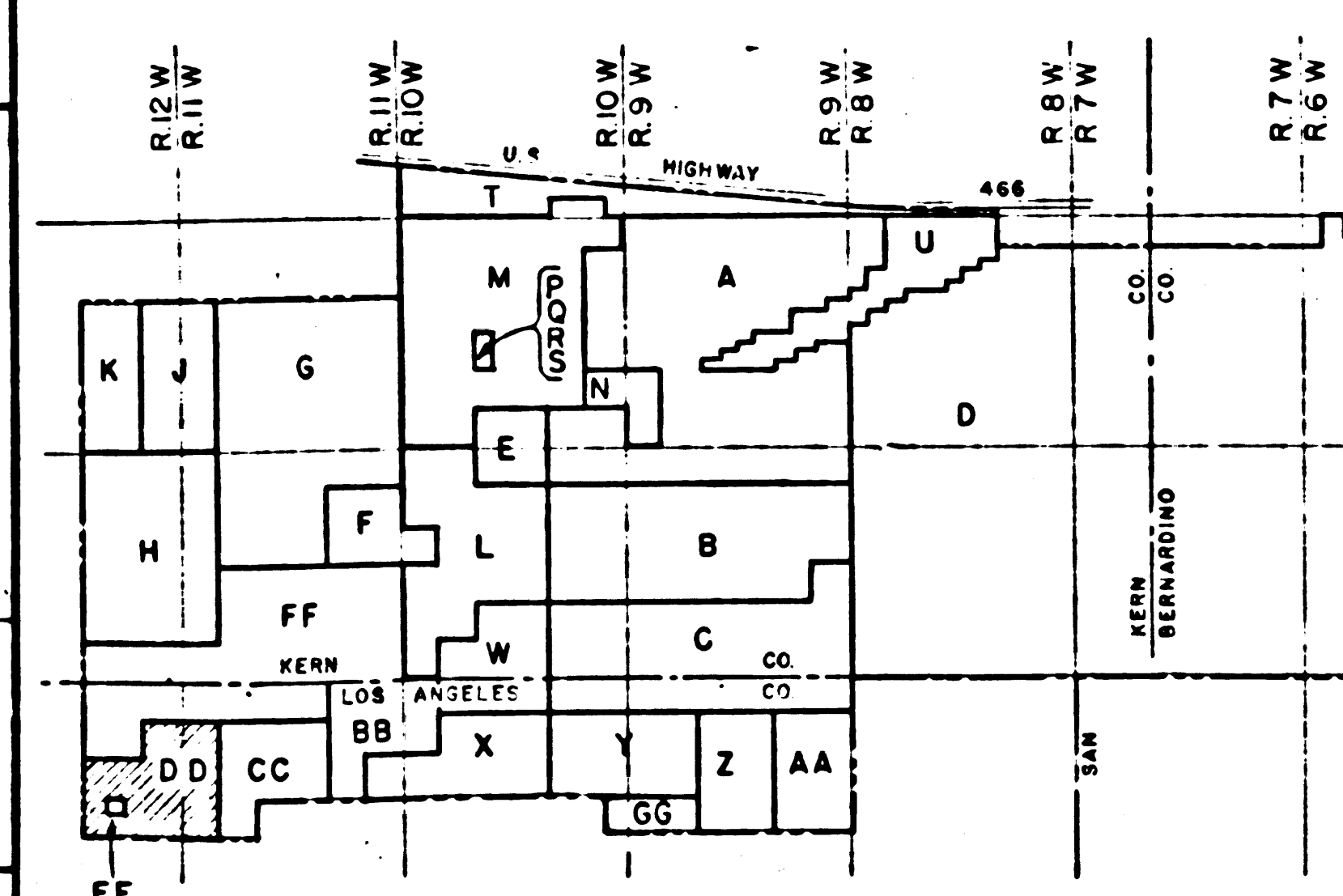

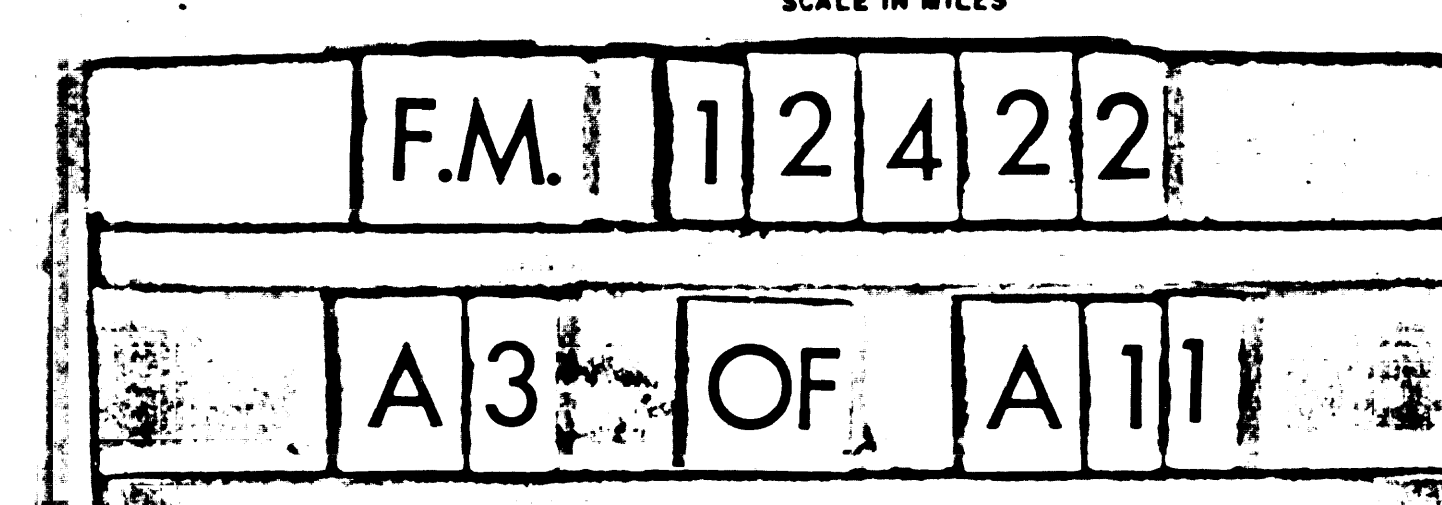


PROJECT SITE

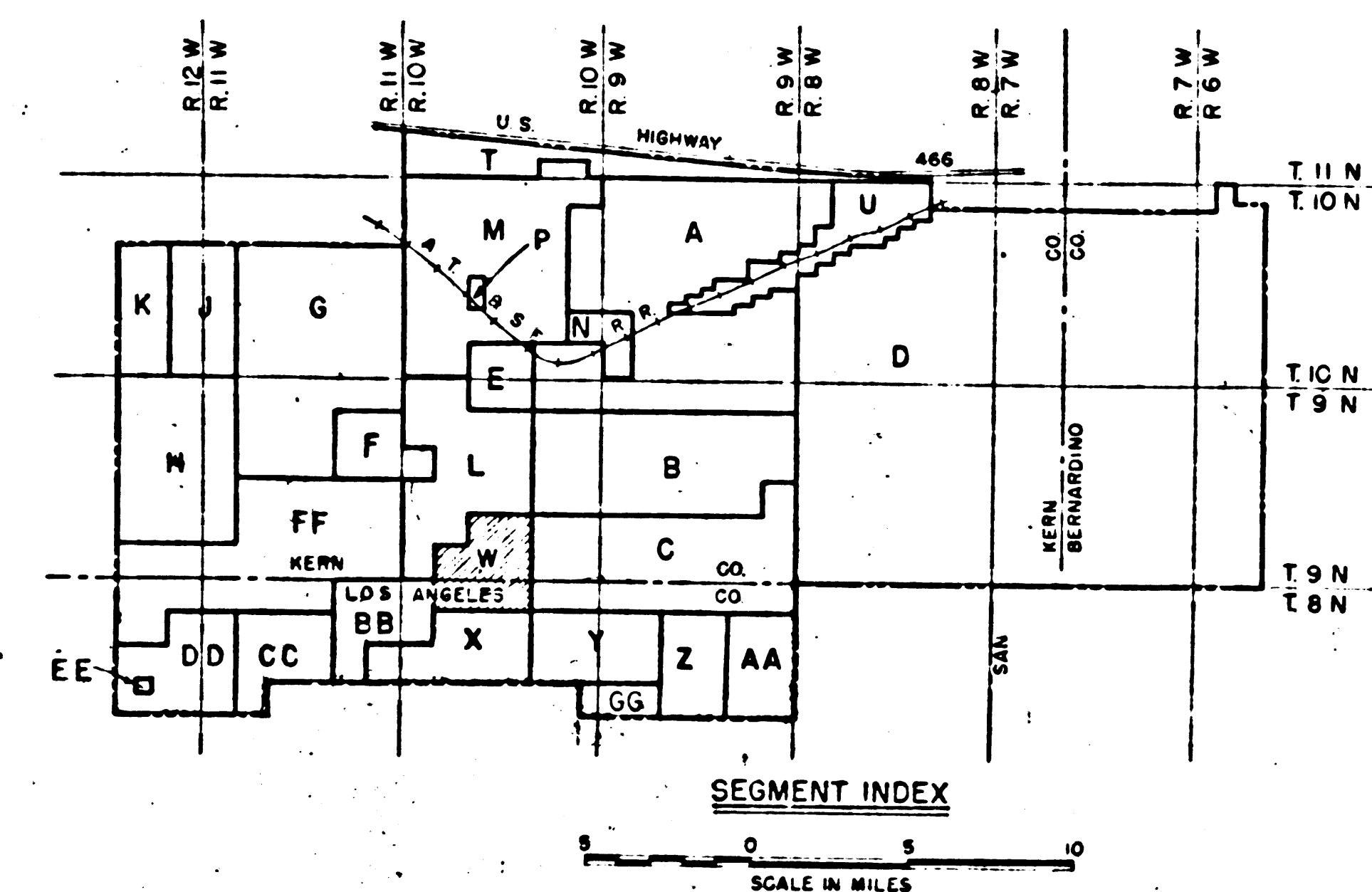

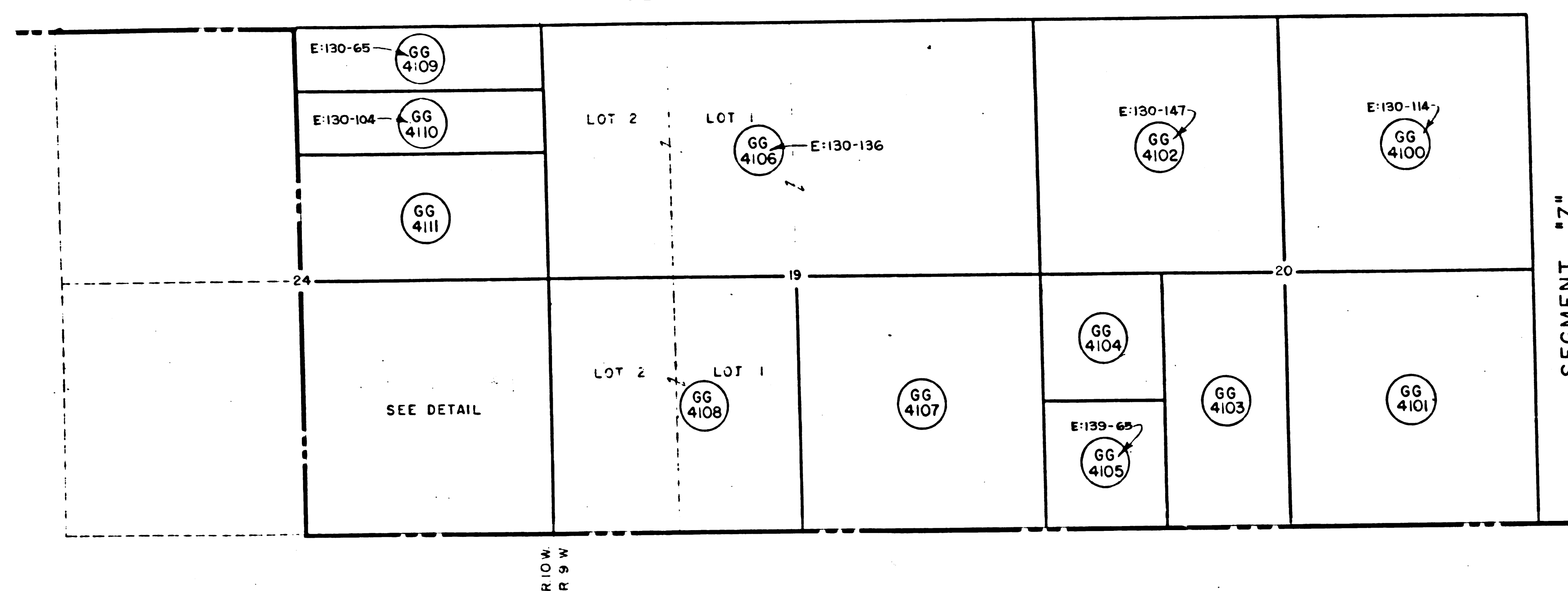
