In re Vacation of Streets Roads and Alleys in the Townsite of Santa Fe Springs

This matter having been set for hearing February 9<sup>th</sup> 1894 and regularly published in accordance with law and the order of the Board required, and continued without date, pending the filing with this board of deeds to certain portions of Third Street, Santa Fe Springs, and said deeds having been filed with and accepted by this Board and the petition of F. C. Howes, et al, herein, coming on at this time to be heard, upon motion of Supervisor Woodward, duly seconded and carried, it is ordered that the following described roads, streets and alleys delineated upon that certain map of the Townsite of Santa Fe Springs recorded at pages 38 and 39 of Book 26, Miscellaneous Records of the County of Los Angeles, viz: Whittier Avenue, from Romandel Avenue to the northeasterly line of said Townsite; Fifth Street from Los Nietos Avenue to Whittier Avenue; Central Avenue from 3rd Street to the southerly line of Los Nietos Avenue; Brimson Avenue from Gardner Avenue to Belle View Avenue; D Street from Whittier Avenue to the northerly line of said Townsite; B Street from westerly line of said Townsite to Murray Avenue; C Street from westerly line of said Townsite to Murray Avenue; Belle View Avenue from Los Nietos Avenue to the northeasterly boundary of said Townsite; Haggard Avenue from Los Nietos Avenue to the said Townsite to C Street; Romandel Avenue from the northern boundary of said Townsite to E Street; 7<sup>th</sup> Street from the northern boundary of said Townsite to Haggard Avenue; 8<sup>th</sup> Street from the northern boundary of said Townsite to Haggard Avenue; 9<sup>th</sup> Street from the northern boundary of said Townsite to Haggard Avenue; 10<sup>th</sup> Street from the northern boundary of said Townsite to Haggard Avenue; 11<sup>th</sup> Street from the northern boundary of said Townsite to Haggard Avenue; All the Alleys ways extending through blocks 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 20, 21, 22, 23, 25, 26, 27, 28, 30, 31, 32, 33, 34, 35, 38, 39, 40, 41, 42, 47, 48, 50 and 55 of the said Townsite; A Street from Anaheim Street to Murray Avenue, and also from Romandel Avenue to Los Nietos Avenue; And the following described Roads, Streets and Alleys in said Townsite of Santa Fe Springs, and as shown upon that certain map of Bannisters Addition to Santa Fe Springs, recorded in Book 23 page 60, Miscellaneous Records of the County of Los Angeles, viz: - 4<sup>th</sup> Street from Romandel Avenue to the easterly line of Blocks 32 and 33 of said Townsite of Santa Fe Springs; 2<sup>nd</sup> Street from Central Avenue to the northeastern boundary of said Bannisters Addition; Gardner Avenue from the westerly line of Blocks 20 and 21 of said Bannisters Addition to the Easterly line of said Bannisters Addition; 1<sup>st</sup> Street from Central Avenue to the west line of Block 8 of said Bannisters Addition; That certain road commencing at the northerly line of a road running along the southerly line of said Bannisters Addition between blocks 13 and 14 to Los Nietos Avenue; That certain road commencing at the northerly line of a road running along the southerly line of said Bannisters Addition between blocks 1 and 130 to Los Nietos Avenue; that certain road commencing at the easterly line of a road running along the westerly line of said Bannisters Addition, between Blocks 19 and 20 to the easterly line of Blocks 19 and 20 of said Bannisters Addition; that certain road commencing at the easterly line of a road running along the westerly line of said Bannisters Addition between Blocks 18 and 19 to the westerly line of that certain road running along the Easterly line of Bannisters Addition; That certain road commencing at the easterly line of a road running along the westerly line of said Bannisters Addition between Blocks 17 and 18 to the Easterly line of said blocks 17 and 18; That certain road commencing at the easterly line of a road running along the westerly line of said Bannisters Addition between Blocks 16 and 17 to the westerly line of a road running along the easterly line of said Bannisters Addition; That certain road commencing at the easterly line of a road running along the westerly line of said Bannisters Addition between blocks 15 and 16 to the easterly line of said blocks 15 and 16; and that certain road commencing at the easterly line of a road running along the westerly line of said Bannisters Addition between Blocks 14 and 15 to the easterly lines of blocks 1 and 2 of the Bannisters Addition; be and the same are hereby vacated and abandoned, conditioned upon the filing with the County Assessor, and the recording in the office of the County Recorder of a map showing all property as affected by this order.
