- 1. **Living in Hangars:** Please be reminded that living in hangars is strictly prohibited. Hangars are designated for aircraft storage and maintenance purposes only.
- 2. **Overnight Parking:** Overnight parking is not permitted on the airport premises. We kindly ask all tenants to make appropriate arrangements for off-site parking if needed.
- 3. **Business Conduct:** Conducting business from your standard month-to-month hangar lease agreement is not allowed. If you require additional space or amenities for business activities, please contact airport administration to explore available options.
