Airport Ops & Admin

We encourage airport tenants to use the online Airport Tenant Portal to submit hangar/tiedown maintenance related work requests. This is the best and quickest way for airport management to assign and track progress from the time a request is submitted to the time it is completed. This also allows us to monitor any delays and provide status updates to our tenants directly to their online accounts.

Airport security and operational safety are enhanced when we all remain aware of our surroundings and comply with the airport's rules, regulations, and policies. When operating a vehicle on the airside of the airport, please pay particular attention to helicopter operations. There are numerous areas on the airport where helicopters regularly operate. Driving slowly, keeping a lookout, and monitoring the air traffic frequency when possible are good practices to enhance safety. Be aware that aircraft have the right-of-way at all times on the airside of the airport.

Swift's UL94 unleaded avgas is anticipated to be available for purchase, in addition to 100LL, at the airport starting June 1st. Please contact airport management if you have any questions.
