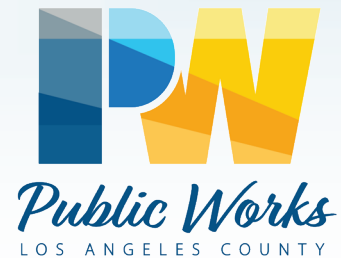

Please make sure that you are prepared with current insurance and registration and airworthiness status for your aircraft. If you have any questions about what is required of you for the annual hangar inspections, feel free to contact us. Also, you do not have to wait until the renewal of your gate card for an inspection of your hangar. You may contact us any time to make arrangements for the annual inspection.

Please remember:

- The Wash Rack is strictly for aircraft washing only.
- There is no overnight vehicle parking on the airport.
- Please ensure your aircraft are stowed in hangars or secured on tiedowns only and **NOT** between the hangar rows.
- It is strictly prohibited to dispose of trash in the airport bins that is brought in from outside the airport.

Board of Supervisors Approves Updated Rents for Non-Aeronautical Use of Aircraft Storage Hangars

At their regularly-scheduled meeting on August 6th, the Los Angeles County Board of Supervisors approved the update of rents for the non-aeronautical use of aircraft storage hangars at the County airports. The non-aeronautical rental rates have not been adjusted since 2019.

The Federal Aviation Administration requires that airport sponsors charge a fair market commercial rental rate for non-aeronautical use of airport storage facilities. The new rental rates, determined through a recent study, are expected to commence in October of this year. Notices will be mailed to all airport tenants impacted by the updated rents.

2024 FAA Reauthorization Act

On May 16th, 2024, President Biden signed into law H.R. 3935, the “FAA Reauthorization Act of 2024”. In addition to reauthorizing the Federal Aviation Administration for the next 5 years and providing for an unprecedented \$4 billion in annual grant funding to airports for eligible projects, the Act addresses various issues impacting general aviation airports. Issues include airport closure, the availability of 100LL aviation gasoline, and ensuring the safe and efficient testing and integration of new technologies such as drones and advanced air mobility into the airspace, among others.
