What a Year 2024 Has Been...

The past 12 months have been busy for the County's five general aviation airports! Following are just some of the events and activities at the County airports this past year.

Brackett Field Airport (KPOC)

- * The airport was selected by the FAA to receive a new and modern Airport Traffic Control Tower. Site selection is currently underway.
- * Design is underway for pavement reconstruction and restriping of the north runway and taxiways. Construction is anticipated to begin in 2028.

Compton/Woodley Airport (KCPM)

* Recognized and celebrated the airport's 100th anniversary.

General Wm. J. Fox Airfield (KWJF)

* MH Fuels took over providing retail aviation fueling services from the County in June. They provide self-service 100LL and full-service 100LL and Jet A.

San Gabriel Valley Airport (KEMT)

- * The airport was selected by the FAA to receive a new and modern Airport Traffic Control Tower. Site selection is currently underway.
- * Design is underway for pavement reconstruction and restriping of the runway and taxiways. Construction is anticipated to begin in 2026.

Whiteman Airport (KWHP)

- * UL94 unleaded aviation gasoline is available for sale as of June 1st.
- * Implemented a voluntary nighttime curfew for aircraft operations.
- * Billion Air Aviation took over retail aviation fuel services from the County in June. They provide self-service 100LL and full-service 100LL and Jet A.

Also this year, Public Works secured preliminary approval from the Federal Aviation Administration of over \$55 million in grant funds for a ten-year infrastructure upgrade plan and implemented a comprehensive Capital Asset Management System for the five County airports.
