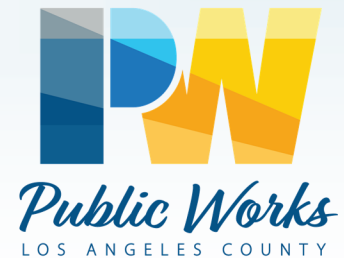

Airport Improvement Projects

Taxilane and Apron Area Pavement Project #1

Public Works plans to begin design later this year to reconstruct some of the paved south taxilanes (J, D, C), taxilanes between hangars, and the eastern apron areas. Construction for the project is anticipated to begin in 2028.

Taxilane and Apron Area Pavement Project #2

Public Works plans to begin the design in 2026 to rehabilitate the remaining paved taxilanes (F, E) and ramp areas on the airport. Construction for the project is anticipated to begin in 2029.

Repair Updates

A motor vehicle operating outside of the airport recently crashed into and damaged the airport's perimeter fence. While repairs are currently underway, this incident is a reminder to always prioritize safe driving, particularly on and around the airport.
