PARADES \ RUN \ BIKE RIDE \ RACE PERMIT GUIDELINES

- 1. Any type of race or mobile event including parades, bicycle and car races, marathons, etc. falls under the jurisdiction of the Los Angeles County Sheriff's Department.
- 2. No person(s) shall conduct, manage, or participate in any race or mobile event unless they first obtain a permit from the Los Angeles County Sheriff's Department per Los Angeles County Vehicles and Traffic Code 15.88.020.
- 3. Applicant is required to contact the local Sheriffs office to obtain the permit to conduct such event.
