

Brackett Field

Serving General Aviation and the Pomona Valley since 1940

Located in the heart of the Pomona Valley, Brackett Field facilitated over 86,000 general aviation aircraft takeoffs and landings during 2018. The airport is home to just under 300 based aircraft and numerous aviation businesses. With an Air Traffic Control Tower operating daily, state-of-the-art navigational aids, and an advanced weather reporting Automated Weather Observing System (AWOS), the airport safely and efficiently accommodates a wide range of fixed-wing and rotary-wing aircraft ranging from small two-seat, single-engine propeller aircraft up to much larger and higher capacity turbo-prop and jet aircraft.

Owned and operated by the County of Los Angeles, the airport is self-sufficient. All income generated by the County at the airport is reinvested back into the airport or the County's system of airports.

Over the next 1-2 years, the County anticipates investing over \$10 million in various capital im-



provement projects at the airport, to include approximately 38 acres of apron pavement rehabilitation. The majority of funding for the various capital

projects comes from Federal Airport Improvement Program grants or State grants from the California Department of Transportation Division of Aeronautics. Additional funding for capital and other projects comes from the County's Aviation Enterprise Fund.

Overall, the airport plays a vital role in the nation's integrated system of airports and is a valuable asset to the local communities, serving the diverse constituents of the City of La Verne, the Pomona Valley and the broader County of Los Angeles.
