Submission of hard copy bids will not be accepted.

BIDS MUST BE SUBMITTED ELECTRONICALLY USING ONE OF THE TWO FOLLOWING METHODS:

#### **Electronic Submission of Bids:**

- Bids may be submitted via e-mail to Messrs. David Pang at <u>dpang@pw.lacounty.gov</u> or Danny Medina at <u>dmedina@pw.lacounty.gov</u>, by or before the bid submission deadline.
- 2. As stated in Addendum 1, in lieu of submitting bids via e-mail, bids may be submitted via <a href="www.bidexpress.com">www.bidexpress.com</a>, a secure online bidding service website.
  - To submit your bids electronically, register with BidExpress, by the due date above. A new registration page must be signed, notarized, and received by BidExpress Customer Support for processing before the due date. There is a nominal service fee to use BidExpress.
  - Please note, each upload of file in BidExpress is limited to 10 MB per file up to 50 files for a total of 500 MB. Bidders shall plan ahead and allow sufficient time to account for the file size limitation before the bid submission deadline to complete the uploading of bid files.
  - If bidder submits a bid through BidExpress, bidder should not send hard copies, CDs, or any other materials to the County via mail.
