1. **Question:** The 5 crews you are requesting for this project, are they to be dedicated to this project through the duration or just as needed?

Response: Contractor shall provide a minimum of five crews throughout the duration of the performance period. Please refer to Scope of Work (SOW), Section C.2.f (page A.13), Performance Period.

2. **Question:** We found a start date but did not find a finish date of the project?

Response: This Contract has been designed to have a potential maximum contract term of 5 years, consisting of an initial 1-year term and four potential additional 1-year option renewals. Please note the Fourth paragraph of Sample Agreement. The start date and finish date of each Performance Period can be found in SOW, Section C.2.f (page A.13), Performance Period.
