# REQUEST FOR PROPOSALS – ADDENDUM 1 AS-NEEDED PUBLIC CURBSIDE REFUSE CONTAINER COLLECTION AND DISPOSAL SERVICES FOR EAST LOS ANGELES (2008-AN031)

Thank you for attending our mandatory Proposers' Conference for As-Needed Public Curbside Refuse Container Collection and Disposal Services for East Los Angeles (2008-AN031) on June 30, 2008. The following are revisions to the Request for Proposals (RFP) as well as clarifications and responses to questions raised.

The deadline to submit proposals has been extended to **Thursday**, **July 17**, **2008**, **by 11:00** a.m.

(Please note that **bold** text has been added and any text that has a strikethrough has been deleted from the RFP.)

#### **REVISIONS**

- 1. PW-2, Schedule of Prices, has been deleted in its entirety and has been replaced with PW-2.1.
  - Please refer to Form PW-2.1, Schedule of Prices (Enclosure A), which is enclosed.
- 2. Exhibits E.2 and E.3, lists for Public Curbside and Refuse Container Collection and Disposal Services for East Los Angeles, have been deleted in their entirety and have been replaced with E.2.1 and E.3.1.
  - Please refer to Exhibits E.2.1 and E.3.1, lists for Public Curbside and Refuse Collection and Disposal Services for East Los Angeles (Enclosures B and C), which are enclosed.

It is to your benefit to fully review and understand the revisions that have been made. Please use the revised forms when submitting your proposal.

- 3. Exhibit A, Section 1, Scope of Work, Paragraph C, Work Description has been revised to read:
  - 1. Scope of Service

The work to be accomplished shall include the furnishing of all administration, labor, supervision, material, equipment for the collection, transportation, disposal of refuse collected from all public curbside refuse containers in the unincorporated areas of the East Los Angeles area. There are currently 82 99 public curbside containers in the East Los Angeles Area furnished by Public Works, which are located on or within a public or private road easement for pedestrians to dispose of refuse.

#### 2. Disposal of Collections

The Contractor shall dispose of all refuse collected at permitted facilities, pursuant to the Los Angeles County Code, Title 20 and all other Federal, State, and local laws and regulations.

The Contractor shall pick up any waste inside the trash-containers that may have slipped between the bag and liner, and waste from spilled containers, and any loose waste that has fallen onto the public sidewalk/street surrounding the container. plastic trash liners that may have slipped between the plastic bag, liner, and wrought-iron receptacles. The Contractor shall pick up waste from spilled containers, and any loose waste that has fallen onto the public sidewalk/street surrounding the container. Public Works will supply the plastic liner and wrought-iron trash receptacles. The Contractor shall supply the plastic bag that fits inside the plastic liner and shall replace the plastic trash bags each time trash is disposed. The Contractor shall also dispose of bagged refuse surrounding the containers.

#### **CLARIFICATIONS**

1. Public Works will accept audited financial statements from the parent of a Proposer as long as the guaranty is in the form provided by the Director and submitted with the parent's financial statements. Proposers must contact the contract analyst, Ms. Barbara Baiz, for a copy of the guaranty if you intend to submit parent's financial statements.

It is to your benefit to fully review and understand the revisions that have been made to the RFP. Sealed proposals must be submitted to the Public Works Cashier by the deadline mentioned above.
