## Question and Answer to On-Call Haul Truck Services Program

**1. Question**: Form PW-9 for subcontractors: Why do subcontractors need to complete this form? This information (ie: SBE, DBE, DVBE, etc.) is provided for each subcontractor on form PW-8 along with the corresponding certification. I believe PW-9 is redundant- can it be required for proposers only?

**Response**: No. Form PW-9 cannot be required for Proposers only. If Subcontractors are to be employed, Proposers must complete and submit Form PW-9 for each Subcontractor. Form PW-9 not only provides information related to the various County's Preference Program, it also provides statistical data regarding the overall composition of each participating Contractor/Subcontractor, such as Business Structure, Race/Ethnic composition, etc. Please refer to Part I, Section 2.A.11, Subcontractor Form List, for additional information.
