Please take note of the following revisions to the IFB. (Please note that the changes that have been added are in **boldface** and deleted languages are ~~strikethrough~~.)

A. The first paragraph of the IFB Notice has been revised as shown below:

PLEASE TAKE NOTICE that the Department of Public Works (Public Works) invites bids for the Lennox and Malibu Garbage Disposal Districts (2018-GDD017) contracts. Public Works may award up to a total of two contracts for these areas: one for the Lennox Garbage Disposal District and one for the Malibu Garbage Disposal District. Each area will be evaluated and awarded separately. These contracts have been designed to have a potential maximum contract term of 44 **10** years, consisting of an initial ~~7-year~~ term **of approximately 7 years** and potential additional two 18-month option renewals. The total annual contract amount of these services is estimated to be \$1.5 million for the Lennox Garbage Disposal District and \$1 million for the Malibu Garbage Disposal District.
