1. Question:  
There is a section on the RFP on fines/penalties how many times or how much has the incumbent company been fined throughout the term of the contract?

Response:  
Public Works has not imposed any fines or penalties to the current contractor during the term of this contract.

2. Question:  
Will all the radios needed for this contract be provided by the County at no cost to the contractor?

Response:  
Yes, please note Exhibit A, Scope of Work, Item G.1.c., County-Furnished Items, on page A.10, "The County may provide radios for the contractor's use."

Are security officers required to be relieved during break or lunch? Can they leave their post unattended during that time?


Response:
