INVITATION FOR BIDS – INFORMATIONAL UPDATE 1 STREET SWEEPING SERVICES FOR SOUTH WHITTIER (2016-PA032) AZUSA/COVINA/CLAREMONT (2016-PA034)

Please take note of the following clarifications to the Invitation for Bids (IFB) for Street Sweeping Services for South Whittier (2016-PA032) and Azusa/Covina/Claremont (2016-PA034), issued on December 22, 2016. Questions presented in this informational update represent the questions asked by the Bidders in the form and context as submitted.

CLARIFICATION

1. **Question:** What is the current curb mile rate for the streets? (Same question for both South Whittier and Azusa/Covina/Claremont)

Answer: Please see rates on the attached Forms PW-2 Schedule of Prices for South Whittier and Azusa/Covina/Claremont (Enclosures A and B).

2. **Question:** What is the current curb mile rate for the alleys? (Same question for both South Whittier and Azusa/Covina/Claremont)

Answer: Please see rates on the attached Forms PW-2 Schedule of Prices for South Whittier and Azusa/Covina/Claremont (Enclosures A and B).

3. **Question:** What is the current per hour rate for call outs? (Same question for both South Whittier and Azusa/Covina/Claremont)

Answer: There are no rates for call outs on either contract.

4. **Question:** What is the average monthly billing for the past 12 months? (Same question for both South Whittier and Azusa/Covina/Claremont)

Answer: The average monthly billing for the past 12 months is \$33,500 for South Whittier and \$21,500 for Azusa/Covina/Claremont.

5. **Question:** Which company is the current vendor? (Same question for both South Whittier and Azusa/Covina/Claremont)

Answer: CleanStreet, Inc. is the current Contractor for both South Whittier and Azusa/Covina/Claremont.

6. **Question:** For how many years have they been providing service? (Same question for both South Whittier and Azusa/Covina/Claremont)

Answer: CleanStreet, Inc. has been providing services to both contracts for 5 years.

7. **Question:** How many trucks are they using on a daily basis? (Same question for both South Whittier and Azusa/Covina/Claremont)

Answer: They are using two trucks for South Whittier and one truck for Azusa/Covina/Claremont on a daily basis.

8. **Question:** How many loads per day are being done by each truck?

Answer: One load for South Whittier and up to two loads for Azusa/Covina/Claremont.

9. **Question:** Where is the current vendor disposing of the sweeping debris?

10. **Question:** What is the start date of this agreement?

Answer: The approximate start date for both of these contracts will be June 1, 2017.

13. **Question:** Are there schools zones or other time- sensitive areas that need to be swept at a certain time? (Same question for both Valinda/Hacienda Heights and West Whittier)

Answer: There are school zones and other time sensitive areas that need to be swept for South Whittier and Azusa/Covina/Claremont. As referenced in Exhibit A, Paragraph F, No. 4:

Streets adjacent to schools and commercial developments shall be swept prior to 7 a.m. or such time as daily public activities start.

14. **Question:** Current pricing for both Azusa/South Whittier?

Answer: Please see our response to questions Nos. 1, 2, and 3, above.

15. **Question:** Current tonnage report and water usage report for both?

Answer: The current tonnage report for the period of December 2015 through November 2016 is 188 tons for South Whittier, and 417.37 tons for Azusa/Covina/Claremont. The current water usage for the period of December 2015 through November 2016 is 181 cubic feet for South Whittier, and 172 cubic feet for Azusa/Covina/Claremont.

16. **Question:** Proposed start date for both?




