The following answer is in response to the request for information and clarification and other questions submitted by Bidder for the On-Call Channel Right-of-Way Clearing Services – San Gabriel River (BRC0000312). The question presented in this Informational Update represents the question asked by the Proposer in the form and context submitted.

1. **Question**: Is the contractor responsible to remove any hazardous waste and belongings left behind due to the current transient situation on County property?

Response: Please refer to Section J, Removal of Debris and Dump Sites, of Exhibit A, Scope of Work which states the following: "The Contractor is advised that due to the nature of this Contract, discarded hazardous waste may be encountered during the performance of this Contract. In the event an unknown substance or hazardous material is discovered, the Contractor shall immediately notify the PWR. The Contractor shall NOT attempt to perform any type of hazardous waste remediation not included under the Scope of Work of this Contract including identifying, containing, cleaning, moving, disposing, etc. The Contractor shall exercise extreme caution in the event unknown waste is encountered."
