REQUEST FOR PROPOSALS – INFORMATIONAL UPDATE 1 OPERATION OF A COMBINED INFANT AND CHILD CARE CENTER (2009-AN029)

Thank you for attending our mandatory Proposers' Conference for Operation of a Combined Infant and Child Care Center (2009-AN029) on Thursday, October 15, 2009. The following clarifications have been made to the Request for Proposals (RFP) in response to questions asked at the Proposers Conference.

1. **Question:** It is my understanding that the Contractor has to pay the County back for the difference in tuition fees between the sponsored rate and public rate?

Response: Yes, the Contractor has to pay the County the difference in tuition fees between the Sponsored rate and public rate. Refer to Sample Agreement, FOURTH Paragraph, page 1 of 4, which addresses the rates of County/Sponsor employees and non County/Sponsor employees (public).

2. **Question:** In reviewing the RFP, there might have been conflicting information as to who is responsible for the landscaping and extermination services. Please clarify who is responsible?

Response: The Contractor is responsible for obtaining landscape and exterminator services and paying the providers. County will reimburse the Contractor on a quarterly basis. Refer to Sample Agreement, SIXTH Paragraph, page 2 of 4, which clarifies who is responsible for the exterminator and landscaping services at the child care center.

3. **Question:** Can one of us come at a later time to look at the facility?

Response: No, you will not be able to visit the facility for this solicitation.


