### **REQUEST FOR PROPOSALS – ADDENDUM 1 EMERGENCY SEWER SYSTEM REPAIR PROGRAM (2009-AN019)**

Thank you for attending our mandatory Proposers' Conference for Emergency Sewer System Repair Program (2009-AN019) held on Monday, June 29, 2009. The following revisions have been made to the Request for Proposals (RFP). Please note that **bold** text has been added and text that has a ~~strikethrough~~ has been deleted from the RFP.

#### **REVISIONS**

1. The enclosed Form PW-2, Schedule of Prices, has been revised, which will facilitate the submittal of a more accurate estimate of costs for providing the services listed in this RFP.
2. Exhibit A, Scope of Work, Paragraph I, Responsibilities of the Contractor, 9.a., has been revised as follows:

- a. ~~Specifications for Public Works Construction (Greenbook), 2009 edition, and any subsequent supplements and editions as published by Building News, Inc., 3055 Overland Avenue, Los Angeles.~~

#### **CLARIFICATIONS**

1. The pagination in Part I, Section 5 Protest Policy, skips from page 126 to page 1.28, although there is no page 1.27 shown, all the information pertaining to this section is complete in the RFP.
2. Budget Reduction (Exhibit B, Section 1, D., Page B.5) shall remain unchanged, please take this into consideration when providing your calculations in the Schedule of Prices, Form PW-2. This language reserves County's right to reduce the scope of work required from the vendor, based on the finances of the County.
3. For Item No. 6, Condition A of Form PW-2, Schedule of Prices, assume a thickness of 6 inches for the asphalt.
4. For Item No. 8, Condition A of Form PW-2, Schedule of Prices, include only the price for the lateral connection at the wye. No excavation for the house lateral is required.

It is understood and agreed that where quantities, if any, are set forth in the Schedule of Prices, they are only estimates, and the unit prices quoted, if any, will apply to the actual quantities, whatever they may be.

The Schedule of Prices for Condition A is for a sample condition for the sole purpose of evaluation of each Proposal. The actual compensation for work performed will be paid as Extra Work per Section 3-3 of the GREENBOOK (as mentioned in the Scope of Work, Exhibit A, I.9. of this RFP). This will not preclude a Negotiated Unit Price for the Items of Work.

**Pipeline Lining – (CONDITION B)**

The Schedule of Prices for Condition B is for a sample condition for the sole purpose of evaluation of each Proposal. The actual compensation for work performed will be paid as Extra Work per Section 3-3 of the GREENBOOK (as mentioned in the Scope of Work, Exhibit A, I.9. of this RFP). This will not preclude a Negotiated Unit Price for the Items of Work.

**PLEASE NOTE THAT PRICE ESTIMATES MAY BE SUBMITTED FOR BOTH PIPELINE RECONSTRUCTION AND SEWER PUMP STATION REPAIR (CONDITION A) AS WELL AS PIPELINE LINING (CONDITION B) WORK.** Proposers will be considered for award of a Contract for Condition A work only if the proposer has submitted a price estimate for Condition A work on this Schedule of Prices. Similarly, Proposers interested in a Contract for Condition B work must submit a price estimate for Condition B in this Schedule of Prices.

**PIPELINE RECONSTRUCTION AND SEWER PUMP STATION REPAIR – (CONDITION A)**

- a) Pipeline reconstruction is the removal and replacement of existing 8-, 12-, 15-, and 18-inch lines.
