Addendum

1. Part I, RFP, Section U, SPARTA Program, page 1.8, has been added to read:

U. SPARTA Program

A County program, known as 'SPARTA' (Service Providers, Artisan and Tradesman Activities) may be able to assist potential Contractors in obtaining affordable liability insurance. The SPARTA Program is administered by the County's insurance broker, Merriwether & Williams. Questions

1. **Question:** Does a Maintenance Gardener Pest Control License meet the requirement for pest control business license?

Response: No, The Maintenance Gardener Pest Control License does not meet that licensing criteria. The Pest Control Business License is a minimum requirement as referenced in Part I, Section 1.B.2, page 1.1 of the RFP.

Question: For the Qualified Applicators License requirement, is Category "C" Right-of-Way the only category acceptable? If not which other categories are acceptable?

<u>Answer:</u> Yes. The Qualified Applicator License in Right-of-Way Chemical Weed Control is the only category acceptable to meet the minimum requirement as referenced in Part I, Section 1.B.3, page 1.1 of the RFP.

3. **Question:** Are the current contractors and prices available on the county site, I could not find them on the site?

<u>Response:</u> No, the current Contractor and prices are not available on the County site. The current Contractor for all areas is Quality Sprayers, Inc. The Normal Working Day Hourly Rate for the **large** spray rig is \$55 and for the **small** spray rig is \$50 for all areas.
