## REQUEST FOR PROPOSALS - ADDENDUM 1 AS-NEEDED FLAGGING SERVICES (2012-AN003)

PLEASE TAKE NOTICE as a result of the mandatory Proposer's Conference held on April 2, 2012, the following revision was made to the minimum requirements to the Request for Proposals (RFP). (Please note that **bold** text has been added, and any text that has a strikethrough has been deleted from the RFP).

**Minimum Requirement(s):** Proposers must meet all minimum requirements set forth in the RFP document at the time of proposal submission including, but not limited to:

- 1. Proposer or proposer's subcontractor, if any, must have a minimum of two years of experience performing flagging services similar or same as described in the Scope of Work.
- 2. Proposer's flaggers must possess a valid and active certification by the American Traffic Safety Services Association (ATSSA) or an equivalent recognized agencies that provides flagger training based on and as required by the California Manual on Uniform Traffic Control Devices (CAMUTCD) latest edition. Proposer shall provide documentation that demonstrates training received is in compliance with the CAMUTCD latest edition.

A new mandatory Proposers' Conference will be held on Wednesday, April 18, 2012, at 9 a.m. at Public Works Headquarters, 900 South Fremont Avenue, Alhambra, California 91803, in Conference Room A, to allow Proposers who are certified by an equivalent recognized agency to also take part in the solicitation process. Proposers who attended the conference held on April 2, 2012, are not required to attend the conference on April 18, 2012. Public Works will reject any proposals from those whose attendance at either the April 2 or April 18 conferences cannot be verified. Attendees should be prepared to ask questions during the conference about the specifications, proposal requirements, and contract terms. After the conference, any additional questions must be submitted in writing within three business days from the

date of the conference. After the third business day, it may be impossible to respond to further requests for information.
