**Important:** This Schedule of Prices based on time-and-materials shall be for work to be performed within approximately the initial 70-hour period of a declared disaster/emergency, or such a time period otherwise deemed reasonable in accordance with FEMA guidelines. Requests for work to be performed outside of the reasonable time period window shall be awarded to the Program's most responsive and responsible low bid responding to the bid request for work to be performed in accordance with Exhibit A, Section Q, Assignment of Work.

### PHASE 1: DEBRIS CLEARANCE

Hourly rate shall be computed from the time Contractor arrives to a Public Works facility to the time Contractor leaves from a Public Works facility. Public Works shall not pay for travel time. Items not listed in this Form PW-2, will be paid on an actual cost basis plus markups for Labor 20%, Materials 15%, Equipment Rental 15% and Other Items/Expenditures 15%. These costs shall not be included in the unit prices listed below.
