Changes:

1. In the Scope of Work, under Section B., Work Locations, on page A.1, the second paragraph has been changed to read:
 - Exhibit F consists of maps of the areas within Zero-Tolerance Zone 5D (**These County unincorporated areas are on the following** Thomas Guide pages: 4551, 4552, 4465, 4373, and 4374, **4375, and 4464**). Also included as part of Zone 5D is the area of Vasquez Rocks that lies within the designated boundaries of Davenport Rd. on the South, Canyon Quail Tr. on the West, Sierra Hwy at the North, and Agua Dulce Canyon Rd. on the East (~~The maps for Agua Dulce and Vasquez Rocks will be provided at the proposers conference~~).
