Please take note of the following revisions to the Invitation for Bids. (Note that the changes that have been added are in **boldface** and deleted languages are ~~strike through~~.) Section A is the Addendum and Section B is the Questions and Answers.

A. Addendum

1. The first paragraph of the Notice of Invitation for Bids has been revised as follows:

PLEASE TAKE NOTICE that Public Works requests bid submissions for the On-Call Channel Right-of-Way Clearing Services – West Area (BRC0000313) contract. This contract has been designed to have a potential maximum contract term of 4 years consisting of an initial 1-year term and potential additional three 1-year option renewals. The total annual contract amount of these services is estimated to be ~~\$1,725,000~~ **\$3,450,000**. The Invitation for Bids with contract specifications, forms, and instructions for preparing and submitting bids may be requested from Messrs. B. Question and Answer to On-Call Channel Right-of-Way Clearing Services - West Area

The following answers are in response to the request for information and clarification and other questions submitted by bidders for the On-Call Channel Right-of-Way Clearing Services – West Area (BRC0000313). Questions presented in this Informational Update represent the questions asked by the proposers in the form and context submitted.

1. **Question:** May we please inquire if the engineers estimate posted on the bid summary page remains the same after the price sheet frequency updated to three times per year of Type A Work and one time per year for Type B Work per the latest addendum? As a reference it states: "Estimate: \$1,725,000.00" which was shown on the bid summary page before the latest addendum.

Response: The total annual contract amount of these services due to the revised frequency is estimated to be \$3,450,000. Please note that this amount is only an estimate to assist proposers and it should not be considered a maximum or an actual contract amount.

2. **Question:** On the updated price sheet, Type A work is bid for it being done three times a year. Will this frequency of three times change the following year(s)?

For example, on item #84 Golf Club Debris Basin, if Type A work is done three times in the first year of the contract, is Type A work going to be done one time the following years or change its frequency the following years? Or will it always be done three times a year for Type A work in all contract years?

Response: The revised frequency applies to the initial contract term and all optional years, if exercised.
