A. Addendum

- 1. In Exhibit B, Section 2.K Consideration of Hiring GAIN and GROW Participants, the following has been modified to read as follows:
 - 1. Should Contractor require additional or replacement personnel after the effective date of this Contract, Contractor shall give consideration for any such employment openings to participants in County's Department of Public Social Services Greater Avenues for Independence (GAIN) Program and General Relief Opportunity for Work (GROW) Program who meet Contractor's minimum qualifications for the open position. For this purpose, consideration shall mean that Contractor will interview gualified candidates. County will refer GAIN and GROW participants by category to Contractor. Contractors shall report job all openings with job requirements to: GAINGROW@dpss.lacounty.gov and BSERVICES@wdacs.lacounty.gov and DPSS will refer gualified GAIN/GROW job candidates.
