The following revisions are made to the Channel Right-of-Way Clearing Services – South Area (2014-AN029) RFP. Added words are shown in **bold** and deleted language is ~~struck out~~:

A. ADDENDUM

Form PW-2, Schedule of Prices, shall be deleted in its entirety and replaced with **Form PW-2.1 (Enclosure)**. Please use enclosed Form PW-2.1 when submitting your proposals.

B. CLARIFICATION

The following answers are in response to the request for information and clarification submitted by attendees of the As-Needed Channel Right-of-Way Clearing Services – South Area (2014-AN029) Proposers' meeting. Questions presented in this addendum represent the questions asked by the Proposer in the format and context submitted.

1. **Question:** on Item #30 Project 4601 there is a New area from Graywood to Project 9, unit 3, Line A has the same Linear Footage which is 1,225' and the new section measures about 1,700 Linear Feet? Please let me know if the New area needs to be added the exciting 1,225'?

Response: Yes. The new section of 1,700 linear feet should be added to the existing 1,225 linear feet totaling 2,925 linear feet. Please refer to the above Form PW-2.1, Schedule of Prices.
