REQUEST FOR PROPOSALS – ADDENDUM 2 INFORMATION VERIFICATION AND REVIEW SERVICES (2012-AN006)

Please take note of the following change to the Request for Proposals (RFP):

Subcontractors are allowed only for CPA work; no other work may be subcontracted.

As a result of the change noted above, a new **mandatory Proposer's Conference will be held on Tuesday, February 28, 2012, at 9:00 a.m.** at Public Works Headquarters, 900 South Fremont Avenue, Alhambra, California 91803, in Conference Room B, to allow Proposers interested in using a subcontractor for the CPA work to also take part in the solicitation process.

Proposers who attended the conference held on February 15, 2012, are not required to attend the conference on February 28, 2012. Public Works will reject any proposals from those whose attendance at either the February 15 or February 28 conferences cannot be verified. Attendees should be prepared to ask questions during the conference about the specifications, proposal requirements, and contract terms. After the conference, any additional questions must be submitted in writing within three business days from the date of the conference. After the third business day, it may be impossible to respond to further requests for information.
