2. Part I, Section 1.B, Exclusions from Service, has been revised to include the following item:

## 6. Collection of Solid Waste from Commercial Accounts

This CONTRACT excludes the right and privilege to arrange and provide Task 1 Services to Commercial Premises and Multifamily Premises with 5 or more units. However, on a case-by-case basis, Director may authorize service to these Customers under unusual circumstances such as when there are only a few accounts in a Service Area and it is significantly more efficient to Collect with the Residential Vehicle instead of sending a Commercial Franchise Vehicle.

#### **B. QUESTIONS AND ANSWERS**

1. **Question:** I had a quick questions on the pricing form PW-2.1 for the initial term of the contract there is pricing for 5 items:

#### Monthly Rate for Basic Services

- 1. One 96-gallon Refuse (no food waste)
- 2. One 96-gallon Recyclables
- 3. One 96-gallon Green Waste (w/Food) or one 64-gallon Food Waste
- 4. Bulky Item Service
- 5. Annual Cleanup Event

Total of 1 - 5

However, on the 3 year and the 7 year extension pricing there are only 4 items that aren't inclusive of the annual cleanup. Should I assume that clean up fee would be charged also in those other years at the initial rate?
