REQUEST FOR PROPOSALS – ADDENDUM 1 WHITEMAN AIRPORT CONTROL TOWER EQUIPMENT MAINTENANCE (2009-AN006)

Thank you for attending our mandatory Proposers' Conference for Whiteman Airport Control Tower Equipment Maintenance (2009-AN006) on Monday, March 16, 2009. The following clarifications and revisions have been made to the Request for Proposals (RFP) in response to questions asked at the Proposers' Conference. (Please note that **bold** text has been added and any text that has a ~~strikethrough~~ has been deleted from the RFP.)

Revision:

1. Exhibit E, Equipment to be Maintained, has been revised to delete Window Shades from the list. See Revised Exhibit E.1
2. Exhibit A, Section H, Second Paragraph, Page A.2 has been revised to read:

Hard hats will be worn at all times, **when applicable, per Cal/OSHA requirements**. Suitable clothing, gloves, and shoes that meet Cal/OSHA requirements are required.

Clarification:

1. The Fifth Paragraph of the Agreement remains unchanged. Payment will only be made upon completion of work:

"FIFTH: The CONTRACTOR shall bill upon completion, in arrears, for the work performed during the preceding month. Work performed shall be billed at the hourly rates and unit prices quoted in Form PW-2, Schedule of Prices."

The deadline to submit the proposals is **Monday, April 6, 2009, at 5:30 p.m.**

Equipment to be Maintained

Voice Switch System – Repaired as necessary
Hand Microphones – Replaced or repaired as necessary
Handsets – Replaced or repaired as necessary
Headsets – Repaired or replaced as necessary
Telephone System* – Repaired as necessary
Wulfsberg Radios - Repaired as necessary
ICOM Transceiver – Repaired as necessary
Antenna System – Repaired or Replaced as necessary
Wind Sensor System – Repaired as necessary
DC Electrical System (Battery charger/ inverter & battery) – Repaired or replaced (batteries only) as necessary
Digital Voice Recorder – Repaired as necessary
DVD disks – Replaced as necessary
Signal Light Gun – Repaired as necessary
~~Window Shades – Replaced as necessary~~
Binoculars – Repaired or replaced as necessary

*Telephone System will be repaired as long as parts and manufacture support is available. The telephone system is considered a consumer item and as such repair/ parts/ support is usually limited to a period of time and once that period has exceeded the product is abandoned by the manufacture and can only be replaced. Replacement of the telephone system will then become a direct invoiced item to the County. All FAA circuits to the WHP ATCT are directly accessible from the Voice Switch and some are also interfaced to the telephone system via Tellabs equipment. This Tellabs equipment is no longer supported by the manufacture and parts/ cards are virtually unavailable on the surplus market today and therefore repairs may no longer be possible. Contractor will do what is practically possible to sustain this interface(s), but will not guarantee continued support and may find that as the interface equipment fails, such circuits to the Telephone System will be abandoned.
