Thank you for attending our mandatory Proposers' Conference for As-Needed Haul Truck Services Program (2011-AN039) held on Monday, August 1, 2011.

Please be reminded that the deadline for Proposal submission is **Monday, August 22, 2011, by 5:30 p.m.**

Please take note of the following revisions and supplemental information to the Request for Proposals (RFP). (Please note that **bold** text has been added, and any text that has a ~~strikethrough~~ has been deleted from the RFP.) Questions presented in this Clarification section of this Addendum represent the questions asked by Proposers in the form and context as submitted.

#### A. Addendum

1. Part 1, Section 1, L.2 Local Small Business Enterprise Preference Program, page 1.5, has been added to read:

2. Form PW-2, Schedule of Prices has been replaced in its entirety with Form **PW-2.1** (enclosed) as Items 6 and 7 have been removed, as shown below.

3. Exhibit A, Scope of Work, Item I, Responsibilities of the Contractor, page A.3, Item I.18 has been added to read:

18. **Contractor shall pay its drivers in accordance to paragraph (1) of subdivision (a) of Section 3322 of the Civil Code.**

B. Clarifications

The following answers are in response to the request for information and clarification submitted by attendees of the Proposers' meeting:

1. **Question:** The state of California voted on AB-145 to run trucks in the state the law now requires haul truck brokers to hold a brokers bond, is Public Works requiring this bond as part of this solicitation?

**Response:** Assembly Bill No. 145, Chapter 429, amended Section 34620 and added Section 34510.5 to the Vehicle Code. It requires a \$15,000 payment bond to ensure that all dump truck operators will be paid by the brokers. Public Works is in compliance with Vehicle Code 34510.5, by requiring a faithful payment bond in a sum not less than \$100,000, which exceeds the state requirements.

2. **Question:** Are you planning on using the off-road trucks as part of this contract?

**Response:** No, Items 6 and 7 for Off-Road Trucks have been removed from Form PW-2, Schedule of Prices. Please refer to Section A.2 of this Addendum above.

3. **Question:** Once the list of trucks with drivers is submitted with proposal, what if one or more trucks decide not to be or removed from the list, for whatever reason, can those trucks be replaced?

**Response:** After award of the contract, Contractor may submit a written request to modify their Truck and Driver List; such modifications are subject to obtaining the Contract Manager's prior approval.

Proposers shall commit to the Truck and Driver list submitted with their proposal until the end of the evaluation process of this solicitation.

4. **Question:** What is the time frame allowed to have the truck with driver list to be replaced?

**Response:** The changes will be applied within one business day after the written approval by the Contract Manager.

5. **Question:** Would the change of trucks with drivers list affect the wait list? If so, How would the change, affect the wait list? Can we still have our place on the wait list, would we be placed on the bottom of the list or would we have to restart the process?

**Response:** Changes to the Truck and Drivers List will only affect the wait list if Contractor is unable to provide the number of trucks requested by Public Works. Note that it is to the Contractors advantage to maintain an updated/approved Truck and Driver List at all times.

6. **Question:** Is PW-8 an extension to PW-18.2? PW 8: If check the box Proposer will provide services (20 trucks PW-18.2) w/o use of Subcontractors etc. Would this be consider non-responsive - each Trucker is consider an Independent Contractor the RFP is for Truck Rental.

**Response:** No, Form PW-8, List of Subcontractors, is not an extension to Form PW-18.2, Truck and Driver List. Form PW-8, must list subcontractors to be utilized by the Contractor to perform the services. Form PW-18.2, must list each individual truck with operator that will perform the services being requested. On Form PW-18.2 Proposer must list all trucks with operators whether they belong to the Proposer or any its subcontractors.

7. **Question:** PW18.2 - Driver's License for the owner or his /her driver?

**Response:** Proposer must list Driver's License information for each one of the drivers to be listed on Form PW-18.2. Furthermore, please refer to Part I, Section 2, Proposal Preparation and Submission, Item A.8, Licenses and Certification that Proposer must include in their proposal.
