A. Addendum

Pending registrations will not be accepted.
- 4. Part I, Section 1, B. Minimum Mandatory Requirement No. 4, has been modified as shown below:
 - 4. Proposer must submit a copy of a valid and active Waste Collector Permit naming the Proposer as the permittee or a copy of the application for a Waste Collector Permit naming the Proposer as the permittee issued by the County Department of Public Health (DPH) at the time of Proposal submission. Proposers who do not possess the permits at the Proposal deadline date may submit a copy of a receipt and an invoice from DPH to Proposers for Waste Collector

 - 5. Maintain a valid and active Waste Collector Permit issued by DPH. The use of subcontracting is prohibited. **This permit must stay** valid and active during the term of this contract.
- 7. In Exhibit A, Scope of Work, Section S, Responsibilities of the Contractor, has been modified to read as follows:
 - Maintain or and ensure its Subcontractor(s), if any, performing prevailing wage work, hold a valid and active State of California Department of Industrial Relations Public Works Contractor Registration pursuant to Labor Code 1725.5.
- 8. In Exhibit A, Scope of Work, Section S, Responsibilities of the Contractor, has been modified to read as follows:
 - 4. Maintain and or ensure its Subcontractor(s), if any, maintain a valid and active State of California Limited Specialty Classification C-61, subcategory D38, Sand and Water Blasting License.

B. Questions and Answers

The following answers are in response to the request for information and clarification and other questions submitted by Proposers for the Maintenance Program for Nonadvertising Bus Stop Amenities - North County (2018-PA001). Questions presented in this Addendum represent the questions asked by the Proposers in the form and context submitted.

1. **Question**: Is it required to have a valid and active C-33 State of California-issued Contractor's license when performing graffiti removal services for?

Response: Yes, per Scope of Work, Section G.4.b, one of the many methods of covering or removing graffiti removal is painting over a particular surface. The C-33 State of California-issued Contractor's license is defined as, "A painting and decorating contractor prepares by scraping, sandblasting or other means and applies any of the following: paints, papers, textures, fabrics, pigments, oils, turpentines, japans, driers, thinners, varnishes, shellacs, stains, fillers, waxes, adhesives, water and any other vehicles, mediums and materials which adhere by evaporation and may be mixed, used and applied to the surfaces of structures and the appurtenances thereto for purposes of decorating, protecting, fireproofing and waterproofing." Therefore, the proposer or subcontractor, if any, performing graffiti removal services using the method of painting over as described above, must hold a valid and active C-33 State of California-issued Contractor's license.

2. **Question**: For purposes of completing the LW-8 forms accurately, what will be the anticipated annual term dates for the awarded contract?

a. When listing different hourly rates for field employees to cover the next living wage increase in 2019 and the CPI increases in subsequent option years, we'll need starting term dates to figure out hours worked for each rate in a contract year. For example, if the new term will start July 1st, the proposer may elect to pay July-December months at current hourly, and then January-June of next year with increased hourly to finish the second half of the contract term year.

Response: The anticipated annual term date for the awarded contract is tentatively scheduled for the end of 2018, which may range from the months of October 2018 – December 2018. Please keep in mind these are only tentative dates and are subject to change.

Response: No, when completing the LW-8 Forms, listing the position and/or title will suffice.
