# BOIL WATER NOTICE

**Boil Your Water Before Drinking or Food Preparation to Avoid Illness**

The Los Angeles County Waterworks District No. 29 and the State Water Resources Control Board are advising customers to use boiled tap water or bottled water for drinking and cooking purposes as a safety precaution to avoid stomach or intestinal illness.

The affected area includes customers within the following areas:

- West of Corral Canyon Rd. and Solstice Canyon Rd
- Excluding customers residing at Trancas Canyon and Latigo Canyon

Please see the attached map for additional details on the affected area.

We will inform you when tests show that water is safe to drink and no longer need to boil your water. We are working to resolve this issue as quickly as possible.

The Boil Water Notice comes after the Los Angeles County Waterworks District No. 29 experienced a low-pressure event as a result of a Caltrans bridge replacement project at Solstice Canyon Creek the work took longer than expected and resulted in water outages.

### Do not drink the water without boiling it first



- Boil all water for one (1) minute (rolling boil).
- Let water cool before drinking.
- Use boiled or bottled water for drinking, brushing teeth, and food preparation until further notice.
- Boiling water kills bacteria and other organisms in the water.

### If you are unable to boil your water:

#### Household unscented liquid bleach



- For clear water, use 8 drops (1/8 tspn.) of bleach for 1 gallon of water. For cloudy water, filter through a clean cloth and use 16 drops (1/4 tspn.) of bleach for 1 gallon of water.
- Mix well. Allow to stand for 30 minutes before using.
- Water may taste or smell like chlorine. This means disinfection has occurred.

*Please do not exceed recommended amount.*

#### Disinfection tablets



- Please follow the manufacturer's instructions.
