Methods to Divert Used Print Cartridges

Because print cartridge components contain hazardous materials, they are prohibited from landfill disposal and must be recycled as hazardous waste. Departments should gather their waste print cartridges and send them to a recycler or cartridge remanufacturer.

Takeback Programs

The following County vendors currently take back print cartridges:

- Canon
- Rasix
- Ricoh
- Sharp
- Xerox



County Surplus Program

In June 2007, the County Board of Supervisors passed a motion allowing the County Surplus Program to donate waste print cartridges to non-profit organizations registered as County vendors. Hydration Stations



Hydration stations provide employees with convenient access to clean drinking water and reduce the amount of single-use plastic bottles entering the office waste stream. Employees can use hydration stations to refill their reusable cups and water bottles. County Departments can apply for grants to offset costs of installing hydration stations throughout their facilities.

As an added benefit, County employees add physical movement to their day by walking to hydration stations to refill their water bottles. Many County Departments, such as Animal Control, Child Support Services, and Public Works, have installed hydration stations.
