Food Recovery Challenge

To encourage food waste prevention and reduction, the Federal Environmental Protection Agency reopened their Food Recovery Challenge. The Challenge recognizes partner businesses and organizations, such as County Departments, for setting food waste diversion goals, implementing strategies to reduce wasted food in their operations and communicating the importance of reducing food waste. These goals and strategies on the EPA's website include: food waste donation programs, repurposing food waste as animal feedstock, composting of wasted food and other industrial uses. The deadline to apply is March 31, 2021.

Castaic Lake State Recreation Area Beverage Recycling Program

Los Angeles County Department of Parks and Recreation kicked off a new Beverage Container Recycling Program at Castaic Lake State Recreation Area. Four recycling bins were strategically placed throughout the park. The recyclables are collected by a non-profit organization on an as-needed basis.

This is a 12,658-acre facility that is a local recreational escape for the entire family. The park has forty-one amenities and activities such as: hiking, horseback riding, water boarding, jet skiing and camping. The recreation area is located forty miles north of Downtown Los Angeles and eight miles north of Six Flags Magic Mountain on Interstate 5.
