## SUPPORT - ASSEMBLY BILL 142 (CRISTINA GARCIA) AS AMENDED ON JUNE 26, 2019 - LEAD-ACID BATTERIES

The Los Angeles County Solid Waste Management Committee/Integrated Waste Management Task Force (Task Force) **supports** Assembly Bill 142 (AB 142), as amended on June 26, 2019. If enacted, the proposed legislation, among other things, would:

- Effective April 1, 2022, increase the California Battery Fee on purchase of a replacement lead battery from a \$1.00 to \$2.00.
- During the period of April 1, 2017 until April 1, 2022, maintains a \$1.00 fee imposed on a
  manufacture of each lead-acid battery sold at retail in California. Effective April 1, 2022, the
  lead-acid Battery Manufacture Fee will increase to \$2.00 in perpetuity. A manufacturer is
  defined as a person who manufactures the lead-acid battery and who sells, offer to sale, or
  distribute the lead-acid battery in the State. If no person stated above is subject to the
  State's jurisdiction, then the manufacturer is responsible for payment of the said fee to the
  State.
- Funds from both manufacturer and specified purchaser fees are currently allocated to the State Department of Toxic Substances Control (DTSC). This bill would establish a Lead Acid Battery Recycling Facility Investigation and Cleanup Program, or LABRIC Program, which would be responsible for identifying areas of the state that are eligible for expenditure of moneys from the Lead-Acid Battery Cleanup Fund for certain purposes, with an unspecified funding allocation. The funds are used by DTSC for investigation, site evaluation, cleanup, remedial action, removal, monitoring or other response actions at any areas in the State that may have been contaminated by the operation of a lead-acid battery recycling facility. Currently there are two lead-acid facilities in Los Angeles County, Exide Technologies facility in Vernon [currently closed] and Quemetco, Inc. recycling facility in the unincorporated areas adjacent to the City of Industry. Exide facility is currently undergoing cleanup activities via a \$176.6 million loan/funding from State General Fund to DTSC. The proposed legislation will maintain the current funding allocation for the cleanup activities, however, it will provide funds toward repayment of the Exide \$176.6 million cleanup fund if

and at such time that all lead-acid battery recycling sites in California are investigated and cleanup activities are completed.

The Task Force strongly supports the proposed legislation because it would continue the state efforts to clean up all contaminated lead-acid battery sites, and to protect these sites' neighboring residents and children. Additionally, the proposal provides for a permanent revenue source to provide for the cost of cleanup activities.

Pursuant of the Los Angeles to Chapter 3.67 County Code and California Integrated Waste Management Act of 1989 (Assembly Bill 939), the Task Force is responsible for coordinating the development of all major solid waste planning documents prepared for the County of Los Angeles and the 88 cities in Los Angeles County with a combined population in excess of ten million. Consistent with these responsibilities and to ensure a coordinated and cost-effective and environmentally sound solid waste management system in Los Angeles County, the Task Force also addresses issues impacting the system on a countywide basis. The Task Force membership includes representatives of the League of California Cities-Los Angeles County Division, County of Los Angeles Board of Supervisors, City of Los Angeles, waste management industry, environmental groups, the public, and a number of other governmental agencies.
