**REVISED FINDING OF CONFORMANCE – ADC PILOT PROJECT
SUNSHINE CANYON CITY/COUNTY LANDFILL – SWFP NO. 19-AA-2000**

Recently, the Los Angeles County Integrated Waste Management Committee/Integrated Waste Management Task Force (Task Force) was provided with a copy of your September 9, 2015, letter (enclosed) to Dave Thompson, Program Manager, Sunshine Canyon City/County Landfill (SCL) Local Enforcement Agency (LEA). The letter refers to the postponement of utilizing a non-reusable geosynthetic sheeting as the landfill daily cover at SCL until shortly after September 29, 2015. Please be advised that prior to implementation of the said proposal, the SCL's owner/operator needs to obtain a revised Finding of Conformance (FOC) from the Task Force. Failure to obtain the revised FOC may constitute a violation of the City of Los Angeles and County of Los Angeles land use permits.

The SCL's existing FOC was granted by the Task Force on December 18, 2008, consistent with the following approved land use permits and their adopted/certified Environmental Impact Reports (EIRs) and Mitigation Monitoring and Reporting Programs (MMRPs):

- City of Los Angeles Zoning Ordinance No. 172933: Final Subsequent EIR (FSEIR) and MMRP adopted/certified by the City on December 10, 1999, State Clearing House (SCH) No. 92041953.
- County of Los Angeles Conditional Use Permit No. 00-194-(5): Final EIR (FEIR) and MMRP adopted/certified by the County on November 30, 1993, SCH No. 89071210 and the Addendum to the FEIR and FSEIR adopted/certified on February 6, 2007, SCH No.1989071210.

The FSEIR's Mitigation Measure No. 33 limits the type of materials to be used for the landfill daily cover at SCL to "dirt" material. Thus consistent with Conditions 2 and 16 of the existing FOC, the proposed use of a non-reusable geosynthetic sheeting in lieu of "dirt" as the landfill daily cover would necessitate the need for a revised FOC from the Task Force prior to implementation of the proposal.
