REQUEST FOR CLARIFICATION – ODOR COMPLAINT RESPONDING PROCEDURES FOR THE SUNSHINE CANYON LANDFILL

The Los Angeles County Solid Waste Management Committee/Integrated Waste Management Task Force (Task Force) is respectfully requesting the South Coast Air Quality Management District (District) to provide clarification on the procedures for responding to odor complaints reported to the District, alleging the Sunshine Canyon Landfill (Landfill) as the source.

With the objective of protecting the Landfill's surrounding community, its residents and children's health and safety, the Task Force would like to understand (a) The District's standard protocols and procedures in responding to odor complaints at the Landfill since 2009, (b) if the responding procedures and policies have changed, when did each change take effect and the rationale for the procedural and/or policy changes, and finally (c) the District's <u>current</u> procedures in responding to odor complaints at the Landfill.
