#### I. CALL TO ORDER

The meeting was called to order at 10:07 a.m.

#### II. DISCUSSION OF STRATEGIES FOR PASSAGE OF AB 1090

This Bill has been identified as a priority to provide conversion technologies a level playing field, since current regulations stifle research and development. Mr. Alva mentioned that Staff had directed a letter of support to the Chair of the Assembly Natural Resources Committee (ANRC) supporting conversion technology and AB 1090. Mr. Mohajer explained that as a two year Bill, AB 1090 must be passed by the Assembly at the end of January 2006, meaning it must pass out of the ANRC early in the month, otherwise if the bill stalls in committee, it is "dead" until the 2007-08 legislative session. Because this bill is at a critical juncture, Mr. Mohajer recommended that members of the Subcommittee voice their support to members of the ANRC, and recommend the Task Force members do likewise.

#### III. DISCUSSION ON FORMATION OF STAKEHOLDER ADVISORY GROUP

Logistics of a possible stakeholder advisory group were discussed as a mechanism to involve stakeholders in this process and build support. Staff was asked to prepare a plan for the development of a group, which will be considered at the next meeting.

# III. CLARIFICATION OF CRITERIA FOR CSD'S CONSIDERATION OF FUNDING FOR THE PILOT CONVERSION TECHNOLOGY FACILITY

Mr. Wheless mentioned that a letter from the Sanitation Districts will be ready in early 2006, and touched on the letter's possible main points. Mr. Alva pointed out that because construction of a conversion facility may be partially funded by the Sanitation Districts, the Subcommittee should be cognizant of the Sanitation District's requirements and requests when developing a facility.

#### V. RECAP ON CONVERSION TECHNOLOGY EVENTS/MEETINGS

Mr. Skye suggested that this agenda item be a regular item on future agendas. He also provided a recap of his facility tours at the BRI gasification/fermentation plant in Fayetteville, AR and the Changing World Technology's thermal depolymerization plant
