I. CALL TO ORDER

Meeting called to order at 1:13 p.m. by Ms. Betsey Landis.

II. APPROVAL OF MINUTES FOR JANUARY 18, 2018

A motion was made by Ms. Betsy Landis and seconded by Mr. Phil Doudar to approve the January 18, 2018, minutes as corrected. The motion passed with one abstention. Ms. Betsy Landis made a motion to accept the February 15, 2018, minutes seconded by Mr. Mike Mohajer. The motion passed with two abstentions.

III. REPORT FROM THE ALTERNATIVE TECHNOLOGY ADVISORY SUBCOMMITTEE (ATAS)

Mr. Patrick Holland provided a report from the ATAS meeting. He informed the Task Force members that consultants from Alternative Resource, Inc., (ARI) gave a presentation on a summary table of small scale anaerobic digestion units and in-vessel aerobic composters. The purpose of the presentation was to receive feedback from the subcommittee members on the summary table prior to distributing it to county facilities, commercial establishments, and other entities that need to comply with AB 1826. Mr. Holland reported positive feedback from the subcommittee members.

Ms. Karen Coca asked if the presentation included information on dehydrators and on-site composting units. She expressed her concerns about the lack of clarification available to the organic waste generators who are installing these units on how to handle the material after it is processed. Mr. Holland stated that there is no definitive determination on whether the dehydrators and liquefiers are acceptable tools that truly satisfy the requirements for AB 1826. However, the dialogue will continue, tools and information will be added and made available to educate the public.

Ms. Betsey Landis asked if any studies have been found regarding digestates, different composts, and products of dehydration and its use. Mr. Holland stated that conversion technology could be a helpful tool to process digestates and any other residual material after it has been processed.

The subcommittee also discussed organic waste management noting the differences between the City of Los Angeles' pilot program and the County Sanitation Districts program. The City's program installs incinkerators, and how the organic waste is directed to the waste water treatment plants.

IV. REPORT FROM THE FACILITY AND PLAN REVIEW SUBCOMMITTEE (FPRS)

Ms. Betsey Landis provided a report from the FPRS meeting. She gave an update on Sunshine Canyon Landfill (SCL) starting with the report on the total number of complaints made to the South Coast Air Quality Management District (SCAQMD) hotline regarding odors. During the month of February, a total of 18 complaints were made, and 12 of the 18 complaints did not have field response. In comparison to January 2018, the number of complaints received in February decreased by 44 percent from 32 to 18 complaints. In comparison with February 2017, the number of complaints decreased by 93 percent from 254 to 18 complaints. The total number of complaints received by SCAQMD since 2009 is 11,051. The total number of complaints received by SCAQMD in 2018 is 50. The total number of Notice of Violations (NOV) issued since 2009 is 214. As of March 15, 2018, SCAQMD issued no NOVs for the month of February. The subcommittee requested staff to follow up with SCAQMD and ask for more information on the procedures for responding to odor complaints.

Ms. Landis reported that the Alternative Daily Cover (ADC) Pilot Project at SCL has concluded. However, Public Works intends to extend the ADC project and is finalizing conditions of approval before granting a formal extension. Public Works Staff and Republic Services will discuss the details of the extension. The subcommittee also discussed the responsibilities of the SCL Local Enforcement Agency (LEA).

Ms. Landis also reported that Los Angeles County Department of Regional Planning has not issued the NOV that was recommended by Los Angeles County Department of Public Health based on the Order to Abate dated November 9, 2016 to SCL. Staff will continue to follow up.

Lastly, Ms. Landis provided an update on a 100 gallon and a 10-gallon leachate spill reported on the January 2018 SCL Monthly LEA Report submitted to the LEA. The Subcommittee requested clarification from the LEA regarding how the liquid was disposed.

V. LEGISLATIVE UPDATE

Mr. Ben Cortez gave an update on current legislation and reviewed items on the attached legislative table.

AB 514 (Salas) – Medical Waste: Pharmaceuticals. Mr. Mike Mohajer made a motion to send a letter opposing the bill unless amended, seconded by Ms. Betsey Landis. The motion passed with one abstention.

AB 1036 (McCarty) – Organic waste: Composting. Staff recommended to watch the bill at this time.

AB 1250 (Jones-Sawyer) – Counties: Contracts for personal services. Mr. Phil Doudar made a motion to send a letter opposing the bill, seconded by Mr. Sam Pedroza. The motion passed unanimously.

AB 1663 (Garcia) – Lead-acid batteries. Mr. Mohajer made a motion to send a letter of support, seconded by Mr. Doudar. The motion passed unanimously.

AB 2115 (Santiago) – Vehicles: passing and overtaking: waste services vehicles. Mr. Mohajer made a motion to send a letter of support if amended, seconded by Mr. Doudar. The motion passed unanimously.

AB 2277 (Mathis) – Solid waste facilities: Home-generated pharmaceutical waste: Incineration. Mr. Pedroza made a motion to send a letter opposing the bill unless amended, seconded by Mr. Ron Saldana. The motion passed unanimously.

AB 2660 (Quirk) – Hazardous waste: Surplus household consumer products. Mr. Pedroza made a motion to send a letter of support and amended, seconded by Mr. Mohajer. The motion passed unanimously.

AB 2766 (Berman) – California Beverage Container Recycling and Litter Reduction Act: Market development payments. Staff recommended to watch the bill at this time.

AB 2779 (Mark Stone, Calderon) – Recycling: Single-use plastic beverage container caps. Ms. Karen Coca made a motion to send a letter of support, seconded by Mr. Doudar. The motion passed unanimously.

AB 2832 (Dahle) – Recycling and reuse: Lithium-ion batteries. Mr. Mohajer made a motion to send a letter of support if amended, seconded by Ms. Coca. The motion passed unanimously

SB 1335 (Allen) – Solid waste: Disposable food service packaging: State agencies and large state facilities. Mr. Mohajer made a motion to send a letter of support, seconded by Ms. Landis. The motion passed unanimously.

VI. CITY OF LOS ANGELES EXCLUSIVE FRANCHISE SYSTEM FOR SOLID WASTE COLLECTION AND RECYCLING SERVICES

Ms. Karen Coca provided the attached <u>PowerPoint presentation</u> on the Progress Report for the City of Los Angeles' RecycLA Program, the new franchise system for the collection and management of solid resources for commercial businesses and multifamily complexes. Some of the highlights included in the presentation were RecycLA's structure of programs, program goals and accomplishments, transition effort, service request, missed collections, rates, and labor. Ms. Coca also provided information about the program's transition efforts and challenges, its Customer Service Tracking System, and its monthly rate comparison to other cities.

Ms. Betsy Landis asked about the definition of zero waste from RecycLA's perspective. Ms. Coca defined zero waste as the amount of all material that goes to a landfill today, 65% of that waste shall not be disposed at the landfill by 2025.

Mr. Sam Pedroza asked about lessons learned through the process. Ms. Coca explained the biggest lesson is the operational difference between commercial complexes and single-family homes due to the level of effort to serve a commercial customer being very different from a single-family customer. The complexity of customer needs is the factor that drives the changes in the system.

Mr. Suk Chong provided the attached "Food Waste Prevention Week" presentation to the Task Force. The presentation included an overview of the activities across the County of Los Angeles and the state of California.
