I. CALL TO ORDER

Meeting was called to order at 10:03 a.m.

II. RECAP ON CONVERSION TECHNOLOGY EVENTS/MEETINGS

Paul Alva commented that the Latino National Congress adopted a motion to support conversion technology, and that the Southern California Waste Management Forum will be holding a waste management conference and exhibit on November 9, 2006. It was noted that Chip Clements will be speaking at the conference.

III. UPDATE ON NEW CONVERSION TECHNOLOGY VENDORS

Sue Higgins presented an update on the new technology suppliers for Phase II. Of the 19 companies that contacted the County, 11 submitted responses to the questionnaire sent out by ARI. ARI concluded that none of the companies that submitted responses fully demonstrated compliance with the minimum criteria. Following discussion, Mr. Alva made a motion for the contractor to accept all 11 responses, and to move forward with the nine technology suppliers previously identified as recipients for the Phase II RFI. The motion passed unanimously.

IV. FACILITATION CONTRACT TIMELINE

Jim Binder provided the Subcommittee with a proposed timeline of deliverables over the next several months. He commented that a draft RFI should be distributed to the Subcommittee the first week of October, and to site operators the following week. It was recommended that the draft RFI be sent simultaneously to the Subcommittee, site operator, and host jurisdiction, in order for it to be finalized and approved by the October 19th meeting. Mr. Binder also mentioned that a recommended shortlist will be developed by December 2006, and final interviews will be scheduled for January 2007. Mr. McTaggart commented that ARI should ask the suppliers to submit videos of their conversion technology plants in order for the Subcommittee to garner a better perspective about their facilities.

V. UPDATE ON PUBLIC OUTREACH CONTRACT
