# I. CALL TO ORDER

The meeting was called to order at 10:05 a.m.

#### II. RECAP ON CONVERSION TECHNOLOGY EVENTS/MEETINGS

Chip Clements discussed his presentation at the Southern California Waste Management Forum's annual conference on November 6th. His speech included a general overview of conversion technologies and discussion on the County's upcoming demonstration conversion technology project. On November 14, representatives of ARI and Mr. Skye had a meeting with city staff from the City of Oxnard who expressed interest in the County's proposed facilitation project, as well as activities and partnerships/relationships between the parties involved.

# III. UPDATE ON FACILITATION CONTRACT

According to Ms. Higgins, on October 27th, technology vendors were provided an initial RFI for the facilitation contract which was distributed by email, and followed by a hard copy. Ms. Higgins commented that six of the nine technology vendors would be replying to the RFI with certainty: ArrowBio; Changing World Technologies; Interstate Waste Technologies (IWT); Gem America; International Environmental Solutions (IES); and Ntech Environmental.

Questions were raised regarding consideration of additional MRF facilities; following discussion, the Subcommittee decided to stay with the shortlisted MRF sites previously chosen. Furthermore, Ms. Higgins explained that participating vendors were given December 4 and 15 to submit their technology's technical and cost/economic information. After vendor feedback, these dates were combined and both cost/technical information submittals will be due December 15, with technology vendor interviews scheduled the week of January 22nd.

Mr. Skye explained that Community Recycling, a transfer/MRF station, has been issued a cease and desist order by the Waste Board. Mr. Mohajer made a motion to send a letter to Community Recycling in order to get clarification pertaining to the order and its potential impact on operating a conversion facility. The motion passed.

#### V. DISCUSSION ON INCENTIVES

ARI prepared a preliminary draft memo regarding opportunities for incentives for participating technology vendors. ARI explained that the memo is necessary and would allow vendors the ability to prioritize what forms of support they believe are integral to their perspective projects. By identifying what forms of support are necessary for each technology, ARI can pair the facilities and vendors to each coupling's best advantage. However, before a memo can be distributed, it will be reviewed by the County Council, and additional feedback is expected by Subcommittee members.

# VI. OPEN DISCUSSION

Mr. Theroux introduced Steven Welder, a financial advisor for the North American Development Bank (NADB). NADB is notable for financing environmental projects benefiting communities in close proximity to the U.S./Mexican border. Mr. Welder has volunteered to examine the facilitation project.
