#### I. CALL TO ORDER

The meeting was called to order at 10:12 a.m.

### II. APPROVAL OF MINUTES OF SEPTEMBER 25 AND OCTOBER 21, 2008

The approval of the September 25 and October 21 2008 minutes were postponed until the next meeting date.

#### III. RECAP ON CONVERSION TECHNOLOGY EVENTS/MEETINGS

Mr. McDannel mentioned that the biosolids reduction technology pilot facility is under construction and should be up and running within the coming weeks. Mr. Skye mentioned that he will be moderating a panel discussion on conversion technologies at the GreenXchange Global Marketplace Conference on January 26. The conference will bring together leaders from clean and green technology market-makers from the business, finance, government, research, and environmental NGOs communities.

# IV. UPDATE ON PUBLIC OUTREACH CONTRACT

Mr. Gibson provided an update regarding the public outreach contract. It was noted that Mr. Skye will be meeting with the CA Chamber of Commerce regarding the County's project and conversion technologies the week of January 16th. Mr. Gibson added that Cerrell Associates is in the process of preparing a facility specific outreach plan for the County's project, and has met with representatives of the County of Riverside's Department of Waste Management to discuss this issue.

#### V. UPDATE ON TECHNICAL EVALUATIONS AND NEGOTIATIONS

Mr. Skye provided an update on technical evaluations and negotiations. Once the technical evaluations have been completed, meetings with the proposers will be scheduled in order to develop agreements for the Board of Supervisors' approval. Because of President Obama's commitment to expanding green technologies in his New Energy for America Plan, the Subcommittee voted to send a letter to the Obama transition team regarding the County's project and the need for conversion technologies.

#### VI. PHASE III/IV RFP

The RFPs for Phases III/IV were released in November 2008. The due date for the RFP proposals is February 9th. It is expected that an evaluation committee will be meeting in February to look over the proposals received and provide a recommendation for selecting a contractor for the next phase of the project.

### VII. DRAFT CEQA GUIDELINES FOR GHG

Ms. Mitchell mentioned that the Governor's Office has drafted amendments to the CEQA guidelines that would take into account the impacts of greenhouse gas emissions. AB 32, the Global Warming Solutions act of 2006, now requires the state to include greenhouse gas emissions in CEQA documents. The guidelines are very general at this point, and a lot of discretion is given to the agencies. Public Comments are due January 26. Discussion on AB32 and projects ensued. Consensus was reached to make a recommendation to Task Force to direct staff to review the guidelines to compare with Task Force policy on lifecycle analysis. Mr. Alva made a request to the agencies involved with CEQA preparations to review and provide comments on the guidelines to County staff.

# VIII. TELLUS INSTITUTE REPORT FOR MASSACHUSETTS DEP ON CONVERSION TECHNOLOGIES

Sue Higgins with ARI provided brief background on the Solid Waste Master Plan revision in Massachusetts. The intention of this report was to be a literature review that summarizes data and information on various approaches that the State might consider as it prepares its new Solid Waste Master Plan. Mr. Skye, was provided a copy of this report for review since the County's Phase II report was mentioned. The Tellus report was in some cases found to be incomplete or misleading, and in some cases comes to contradictory conclusions from the County's report. The Subcommittee recommended that the Task Force be asked to review the report and provide comments to the Massachusetts DEP. Staff will ask for a letter to be sent out by next Thursday.

# IX. DISCUSSION REGARDING CONFLICT OF INTEREST REPORTING REQUIREMENTS (FORM 700)

Mr. Alva provided information on this item as it pertains to the Subcommittee. In recent meetings with the Executive Office, it was determined that subcommittee members will now need to provide a complete Conflict of interest Form (Form 700). This form will be further discussed at the next Subcommittee meeting.
