Mr. Coby Skye reported on his recent participation at the Biomass Collaborative Forum held at UC Davis on May 10-11 2010. Where Mr. Skye was invited to attend this conference as a speaker and present on the conversion technology efforts on behalf of the County of Los Angeles.

Mr. Jacques Franco notified the ATAS members of the upcoming Pacific Organics Residual Conference in Sacramento that is scheduled for Sept 14-15, 2010. More information will be disseminated as the date gets closer.

IV. UPDATE ON PUBLIC OUTREACH CONTRACT

Mr. Matt Gallagher with Cerrell Associates provided the update on the public outreach contract. Cerrell and Staff recently met with members of the environmental justice community in Wilmington, CA. The focus of the meeting was to share Dr. William Welch's recent study on emissions from thermal conversion technologies around the world.

Staff is working with Cerrell in coordinating extensive outreach efforts for AB 222, in preparation of the upcoming June 2010 hearing. This included a recent meeting between Senator Lowenthal (D-Long Beach) and County staff members.

V. UPDATE ON PHASE III & IV CONTRACTS

Mr. Jim Binder and Ms. Sue Higgins with Alternative Resources Inc, and Mr. Chip Clements with Clements Environmental provided the update on the Phase III-IV technical contract. ATAS members were informed of the kickoff meetings conducted in coordination with DPW Staff and all three demonstration project development teams and local cities interested in developing a Phase IV project. Consultant staff is working with DPW Staff on the Phase IV feasibility study that is due in six months to the Board of Supervisors. VI. UPDATE ON THE BIOENERGY INTERAGENCY WORKGROUP AND AB118 INVESTMENT PLAN BY JACQUES FRANCO, CALRECYCLE

Mr. Franco informed the ATAS that the California Energy Commission staff will conduct a workshop on June 3, 2010 to solicit stakeholder comments regarding the development of an updated plan to further address barriers and identify solutions to the expansion of biopower and biofuels, including regulatory hurdles and project financing.

VII. "PRESENTATION ON RENEWABLE ENERGY FROM MICROALGAE" BY BARRY TOYONAGA, PHD, KENTBIOENERGY CORPORATION

Kent Bioenergy Corporation is a company that uses algae to remove nutrients from wastewater and other organic wastes. The algae is harvested and dried and put into a digester. The carbon dioxide from the digesters is fed back into the algae ponds, the solid residue is used as a soil amendment, and the biogas is used in the generation of electricity. The company operates production facilities near the Salton Sea.

Members were asked to recommend potential candidates for consideration by next meeting. Among potential candidate to consider are members of cities in LA County and utility companies.

IX. OPEN DISCUSSION
