I. CALL TO ORDER

Mr. Coby Skye called the meeting to order on behalf of Mr. Paul Alva at 10:05 a.m.

II. APPROVAL OF MINUTES OF JULY 2011

The minutes were amended to correct Item VII to reflect that the motion to request staff to return in 1-2 months with a work plan that would revise the current public outreach strategy to focus on conversion technology legislation was adopted with the exception of Mr. Paul Alva who voted no. In addition, Mr. Mike Mohajer request to note on the minutes that Ms. Kay Martin was not present.

A motion was made to approve the minutes of July 21, 2011. The motion was passed unanimously with Mr. Mohajer's amendments.

III. CONVERSION TECHNOLOGY EVENTS/MEETINGS

Mr. Skye reported on WASTECON 2011, this event was well attended and he stated that the largest interest and focus of the event was on conversion technologies. He also stated that the Waste Conversion Technology Congress West Coast will be held on San Jose, California on December 6 and 7, 2011.

IV. UPDATE ON PUBLIC OUTREACH PLAN

Mr. Michael Hinrichs announced that Mr. Matt Gallagher has taken a position in Washington D.C and Michael has now taken over Cerrell's Energy and Environmental Section. Mr. Hinrichs stated that he is been working with his team members to continue the strategy for the outreach work plan update, as requested by the Subcommittee. He also mentioned that their stakeholder database of upcoming conferences and forums has expanded and they are expecting additional contacts to be added into the email list for the e-newsletter and general information.

Mr. Mohajer requested to include work plan as a monthly agenda item until this subject is addressed.

V. UPDATE ON PHASE III & IV CONTRACT

Ms. Traecey Anthony provided an update to the Subcommittee on Phase III & Phase IV efforts. CR&R continues to pursue the permitting process for their anaerobic digestion project in Perris, CA. At this time it appears that the CEQA requirements for this project will be a Mitigated Negative Declaration. Ms. Anthony reported that 35 technology vendors and 11 financial responses were submitted in response to Public Works' Requests for Expressions of Interest. ARI is currently reviewing the responses. The companies that meet Public Works' minimum criteria

will be included in a publicly-available database. Ms. Anthony added that they are considering reaching out to companies that ARI is familiar with but did not respond.

VI. NAVY WASTE TO ENERGY FORUM UPDATE

Dr. Eugene Tseng provided a summary of the July, 29 2011 Department of the Navy Waste-to-Energy Industry Forum that he attended in Washington D.C. The purpose of this forum was to facilitate the exchange of information and to aid in future proposals for waste-to-energy plants for both on and off Department of the Navy sites. Dr. Tseng is currently developing a study on conversion technologies for the Navy, and will provide a copy of the report to Subcommittee members when it is released.
