I. CALL TO ORDER

Mr. Coby Skye called the meeting to order at 10:05 a.m.

II. APPROVAL OF MINUTES FROM MARCH 21, 2013 MEETINGS

A motion was made by Mr. Jeff Yann, seconded by Mr. Wayde Hunter, to approve the minutes with certain amendments. The motion passed unanimously.

III. UPDATE ON CONVERSION TECHNOLOGY PROJECT DEVELOPMENT

Ms. Traecey Anthony provided the following updates:

- The County continues to work with IRS Demolition, Inc. in support of a conversion technology facility at their operation in the City of South Gate.
- The County is currently drafting a 6-month status report to the Board of Supervisors; the report will include an updated listing of stakeholders, updated project descriptions and status.
- As part of ARI's ongoing activities to monitor technologies and provide technical information to stakeholders, they have compiled a listing of companies, including those that are currently on the County's database and others that are not yet listed. The table includes a brief company and technology description, contact information and website links.
- The City of Oxnard released a Request for Proposals (RFP) for the development of a business plan for the City operation and maintenance of the Del Norte Regional Recycling and Transfer Station. Information and a link to this RFP will be included in our next E-notify.
- CR&R Inc., has completed their preliminary engineering drawings for their anaerobic digestion project in the City of Perris, CA, and they expect to break ground in August of this year with a one-year construction period.

IV. UPDATE ON CONVERSION TECNHOLOGY OUTREACH ACTIVITIES

Ms. Macaria Flores provided the following updates:

• In the last month, Cerrell and Associates has focused on assisting the County with outreach to key stakeholders for support of SB 804.

V. RECAP ON CONVERSION TECHNOLOGY EVENTS/MEETINGS

Mr. Coby Skye provided the following updates:

- Mr. Skye stated that SB 804 is currently the main focus of our outreach activities.
- The County participated in multiple meetings with committee staff, state agencies, and other stakeholders in support of SB 804 this past month.
- The County encountered considerable opposition to SB 804 in Sacramento orchestrated by Californians Against Waste, who have circulated misinformation about both the content and the intent of the legislation. County staff is working hard to correct the information.
- SB804 was scheduled to be heard by the Senate Committee on Energy, Utilities, and Communications on April 16, 2013. This hearing has been moved to April 30, 2013.

Mr. Wayde Hunter expressed concerns over the language in the bill and was concerned that the bill does not do enough to correct definitions or provide incentives for conversion technologies.

A discussion of the bill language and the politics surrounding the language followed. Mr. Skye noted that the County continues to be committed to a transparent process moving forward and welcomes input from all stakeholders. Mr. Skye encouraged stakeholders submit support letters for SB 804 with specific details about what kind of language they would like to see in the bill.

Mr. Franco gave an update on the BioCycle conference in San Diego. Next year's conference will be fully devoted to renewable energy. Mr. Franco made a general request to members for ideas about which topics should be discussed at the conference.
