### I. CALL TO ORDER

The meeting was called to order at 10:02 a.m.

### II. APPROVAL OF THE SEPTEMBER 21, 2017 SUBCOMMITTEE MEETING MINUTES

Mr. Benjamin Lucha requested an amendment to the Minutes to designate that he participated over the telephone. A motion to approve the Minutes from the September 21, 2017 Subcommittee Meeting as amended was made by Mr. Wayde Hunter and seconded by Mr. John Kaddis. The motion passed with Mr. Jacques Franco and Mr. Brian Helmowski abstaining because they didn't participate in the September 21, 2017 Subcommittee Meeting.

## III. PRESENTATION FROM SHAWN SMITH OF SOUTHERN CALIFORNIA EDISON, ON THE BIOENERGY MARKET ADJUSTING TARIFF (BIOMAT) PROGRAM

Mr. Shawn Smith of Southern California Edison (SCE), provided a <u>PowerPoint presentation</u> on the Bioenergy Market Adjusting Tariff (BioMAT) program. The program was established by the California Public Utilities Commission (CPUC) to implement Senate Bill 1122 (SB 1122). The bill required investor owned utilities (IOUs) to collectively procure at least 250 MW of RPS eligible energy from bioenergy projects. BioMAT offers bioenergy generators the ability to enter into a Power Purchase Agreement (PPA) with the IOUs to receive set rates depending on the waste category. Category 1 is biogas from wastewater treatment, municipal organic waste diversion, food processing, and co-digestion.

Mr. Smith disclosed that there are only a few projects in the program, and none yet with SCE in Southern California. The Subcommittee attributed the lack of projects to interconnection issues. The program is scheduled to sunset in 2021 and Mr. Smith indicated that at this time it's uncertain if the IOUs would be supportive of efforts to repeal the sunset.

### VI. RECAP ON CONVERSION TECHNOLOGY PROJECT DEVELOPMENT

Ms. Tracey Anthony of Alternative Resources, Inc. (ARI) reported to the Subcommittee that ARI completed a summary table of grants, loans, and other incentives that may be available to help support CT projects. ARI is working with the Department of Public Works to refine the table to serve as a resource to project developers.

#### VII. PUBLIC COMMENT

Mr. Mark McDannel reported that the Sanitation Districts have broken ground at the Puente Hills Materials Recovery Facility (MRF) to install the DODA equipment that would process food waste in March 2018.

Mr. Patrick Holland reported that the Department of Public Works has launched a food waste collection program and campaign to encourage employees to scrape their plates after eating in the Public Works cafeteria. The recycled food waste will be processed at the Puente Hills MRF.

Ms. Betsey Landis expressed concern over the pest infested trees in Los Angeles County that end up being buried in landfills. CTs could serve as an alternative to address the issue.
