CALL TO ORDER

The meeting was called to order at 12:00 p.m.

I. APPROVAL OF MINUTES OF October 21, 2004

The minutes of October 21, were unanimously approved.

II. AMENDMENT TO THE CITY OF CULVER CITY'S NONDISPOSAL FACILITY ELEMENT

Mr. Aiyetiwa stated that Culver City wants to amend its Nondisposal Facility Element (NDFE) to include the City's proposed expansion of its existing transfer station, which would allow the transfer station to accept a capacity of up to 1,056 tons per day (tpd) and to change the weekday hours of operation from 4:30 a.m. - 4:00 p.m. to 4:00 a.m. - 6:00 p.m. Mr. Aiyetiwa stated staff found the City's request to be consistent with the Countywide Integrated Waste Management Plan, and complies with the requirements of State regulations, therefore, he recommended the Task Force's approval of the proposed amendment.

In response to questions from the subcommittee, Mr. Skinner clarified that the transfer station only accepts municipal solid waste and green waste and does not accept commingled waste from collection trucks. All green waste and construction and demolition waste are recovered from the waste received at the transfer station.

A motion was made by Mr. Mike Mohajer that the NDFE amendment submitted by staff be approved.

The Facility and Plan Review Subcommittee unanimously voted to recommend approval of the City of Culver City's NDFE.

III. OPEN DISCUSSION/PUBLIC COMMENT

There were no public comments received.
