

Proposition 218 Notification:

Proposed Annual Rate Increases for Malibu Sanitary Sewer Zone (SSZ)

What is the Malibu Sanitary Sewer Zone?

Sanitary Sewer Zones were established by Los Angeles County Public Works (Public Works) for areas that receive additional sewer services beyond the services provided by Consolidated Sewer Maintenance District. Only property owners benefiting from these additional services pay the rates to cover costs in the specific zones.

The Malibu Sanitary Sewer Zone is a special sewer zone created to collect the necessary funds to pay for wastewater treatment and disposal provided by the Malibu Water Pollution Control Plant operated by Public Works. The costs to operate and maintain the collection system are paid for through the Consolidated Sewer Maintenance District. These sewer service charges are collected through property owners' tax rolls.

Why Are Sewer Rate Increases Necessary?

Public Works is responsible for ensuring the efficient operation and upkeep of the Consolidated Sewer Maintenance District, including Malibu Water Pollution Control Plant which provides wastewater treatment and disposal only for properties within the Malibu Sanitary Sewer Zone.

The Malibu Sanitary Sewer Zone fee has been the same since 2008. Due to inflation, the costs to operate and maintain the Malibu Water Pollution Control Plant have significantly increased and currently exceed the funds collected. To sustainably continue covering the costs for the operation and maintenance of the treatment plant, Public Works is proposing a rate increase for the Malibu Sanitary Sewer Zone.

THE REASONS FOR THE RATE INCREASE INCLUDE:

- Keeping up with the rising cost of collection, treatment, and disposal of wastewater
- Funding essential projects to maintain, rehabilitate, and properly operate the Malibu Sanitary Sewer Zone infrastructure to keep the system running smoothly

HOW TO FILE A WRITTEN PROTEST

Any property owner or tenant who is part of the Malibu Sanitary Sewer Zone service area may submit a written protest for the proposed sewer rate increases. Only one protest will be counted per identified parcel. Written protests must:

- State that the identified property owner or customer opposes the proposed sewer rates
- Provide the property address and assessor's parcel number
- Include an original signature of property owner or tenant submitting protest - An electronic signature CANNOT be counted

Under California Government Code section 53759, there is a 120-day statute of limitations for challenging any new, increased, or extended fee or charge. This statute of limitations applies to the sewer service rates proposed in this notice. COMPREHENSIVE RATE STUDY

The proposed service fee increase was calculated by evaluating the overall cost to provide sewer services to the Malibu Sanitary Sewer Zone. These costs are shared proportionally between properties receiving sewer services as required by Proposition 218. Customers will only be charged the amount that it costs to provide sewer services to their property.

In 2024, Public Works conducted a comprehensive Rate Study for sewer maintenance services. The Rate Study was prepared by an independent, third-party firm. The Study provides a detailed review of Public Works' costs, and the rate structure needed to meet those costs to continue providing safe and reliable sewer maintenance services.
