Why Are Water Rate Increases in District 29, Malibu Necessary?

#### **SAFE, CLEAN, RELIABLE WATER**

Los Angeles County Public Works (Public Works), on behalf of the Los Angeles County Waterworks Districts, provides services that ensure safe, clean, and reliable water to over 260,000 people countywide, including the Malibu and Topanga communities in Waterworks District 29. The District currently serves:

22,826 people in Malibu and Topanga

6,523 metered connections

#### **REASONS FOR THE RATE INCREASE**

Costs to provide water services have continued to increase. To keep pace with rising inflation and maintain reliable services, Public Works is proposing a water rate increase from 2026 – 2030. The reasons for the rate increase include:



#### **Sufficient Funding**

To ensure Waterworks District 29 receives sufficient revenue to keep pace with cost increases and increased operational costs to pump, treat, and deliver water.



#### **Capital Improvement Projects**

To fund essential capital improvement projects to upgrade, repair, maintain, and properly operate the District's water system infrastructure to be more resilient to natural hazards.



#### **New Water Efficiency Regulations**

To align with the State's long-term water-efficiency goals established under SB 606 and AB 1668. New regulations increase costs by requiring Waterworks

- Replace aging water mains to prevent leaks
- Update drought plans and conduct tests to ensure reliable water service
- Establish water-use efficiency goals
- Meet new reporting requirements


#### **How Were Rates Calculated?**

#### **COMPREHENSIVE FEE STUDY**

In 2025, Public Works conducted a comprehensive Rate Study for Waterworks District 29, Malibu. The Rate Study was prepared by an independent, third-party firm. The study provides a detailed review of Public Works' costs to continue providing safe and reliable water to our customers and the fee structure needed to meet those costs. Setting new rates is a collaborative effort involving staff with key data and expertise, professional rate consultants who analyze and recommend solutions, engaged residents and customers, and elected leaders. Proposed rates are determined through evaluation and analysis of cost escalations related to operations and

maintenance, water treatment and distribution, capital project costs, general inflation, and cost increases for materials and power. The costs are distributed proportionally between properties receiving services from Public Works as required by Proposition 218. Customers will only be charged the amount that it costs to provide service to their property.

In addition to the rate increases described in this Notice, commencing January 1, 2026, and any time thereafter through and including December 31, 2030, Waterworks District 29 is proposing to pass through certain inflationary and wholesale cost increases to customers to become effective 30 days after adjustment notices are sent to customers. Adjustments to the rates for wholesale cost increases shall be based on any adopted rate increases by wholesale water providers including the Antelope Valley-East Kern Water Agency, Los Angeles Department of Water and Power, Santa Clarita Valley Water Agency, and West Basin Municipal Water District (each a "Wholesaler") relating to Waterworks District 29's cost to purchase water. Adjustments to the rates for inflation shall be based on the United States Department of Labor, Bureau of Labor Statistics, for the Los Angeles, Riverside, and Orange County areas, published as of July of each year, or if such index ceases to be published, a comparable index as determined by the Director of Public Works. Pass-through adjustments shall not result in the rates increasing by more than 15% in any calendar year, and shall not cause the rates to exceed the cost of providing water service.

#### **Written Protests**

#### **HOW TO FILE A WRITTEN PROTEST**

Any property owner or customer of record who is part of the Waterworks District 29 service area, located in Malibu and Topanga, may submit a written protest to the proposed water rate increase. Only one protest will be counted per identified parcel.

#### Written **protests** must:

- State that the identified property owner or customer opposes the proposed water rates.
- Provide property address or assessor's parcel number.
- Include the signature of the property owner submitting the protest.

Protests may be mailed or hand-delivered to the above address prior to the Public Hearing, so long as they are **received** by Public Works before the close of the Public Hearing on **Tuesday, December 16, 2025**, at 9:30 a.m. This means that protests mailed to Public Works but received after the close of the Public Hearing will not be counted, even if they are postmarked on or prior to December 16, 2025. Protests may also be hand-delivered at the public hearing in Board Hearing Room 381B, located at 500 West Temple Street, Los Angeles, CA 90012. The doors to the Board Room will open after 8:45 a.m., and a Customer Service Representative in the Board Hearing Room (who are identified with badges) will accept protest letters.

# ELECTRONIC SUBMISSIONS WILL NOT BE ACCEPTED

The Board of Supervisors will accept and consider all written protests and will hear and consider all oral comments to the proposed water rate increase at the Public Hearing. Oral comments at the Public Hearing will not qualify as valid protests unless they are accompanied by a written protest. Upon the conclusion of the Public Hearing, the Board of Supervisors will consider adoption of the proposed water rate increases as described in this Notice. If written protests against the proposed water rate increases are not presented by property owners or customers of record representing a majority of the identified parcels subject to the proposed rate increases, the Board of Supervisors will be authorized to adopt the rate increases. ### **Formal Objections**

#### **HOW TO SUBMIT A FORMAL OBJECTION**

This year, Public Works is implementing an administrative remedy and exhaustion procedure relating to the proposed water rates. Property owners and customers of record who will be affected by the proposed rate increases may submit a written legal **objection**. The written legal objection is separate from the protest procedure described to the left.

In order to be valid, written legal **objections** must:

- Indicate that the submission is an objection.
- Specify the grounds for the proposed water rates' noncompliance with Proposition 218 in sufficient detail to allow Public Works to determine whether any adjustments are necessary. Please note that a statement that the proposed rates are too high, or that they are illegal without explaining the basis for such claim, will be insufficient and will not constitute a valid legal objection because it does not provide Public Works sufficient information to determine whether any changes must be made to the proposed water rates.
- Provide property address or assessor's parcel number.
- Include the signature of the property owner or customer of record submitting the objection.

# MAIL OR HAND-DELIVER FORMAL OBJECTIONS TO:

Written legal objections must be received by Public Works by 5:00 p.m. on Tuesday, December 9, 2025. Failure to submit an objection in time to be received by Public Works by 5:00 p.m. on Tuesday, December 9, 2025, will bar any right to challenge the proposed water rates through a legal proceeding. All timely objections received will also be counted as a protest. Any objection received after the deadline and before the close of the Public Hearing will only be considered and counted as a protest. Under California Government Code section 53759, there is a 120-day statute of limitations for challenging the proposed water rate increases, which commences on the date the resolution enacting the proposed water rate increases is adopted. <sup>\*</sup> The current monthly Service Charge includes 5 HCF (hundred cubic feet) of water per billing unit. Beginning January 1, 2026, the Service Charge will no longer include this amount, and all water use will be billed at the Quantity Charge rate. La tarifa mensual de servicio actual incluye 5 HCF (cien pies cúbicos) de agua por unidad de cobro. A partir del 1 de enero de 2026, la tarifa de servicio ya no incluirá esta cantidad, y todo el consumo de agua se cobrará según la tarifa por volumen.
